AN ORDINANCE TO PARTIALLY VACATE FULMER ALLEY FROM 1-3 CAMPBELL TOWARDS THE END OF FULMER ALLEY IN JOHNSTOWN, PENNSYLVANIA, AS A PUBLIC THOROUGHFARE.

WHEREAS, the property owners abutting on 1-3 towards the end of Fulmer Alley in the 17th Ward of the City of Johnstown, have petitioned the City Council of the City of Johnstown to partially vacate Fulmer Alley, and;

WHEREAS, there are no existing utilities within Fulmer Alley, and;

WHEREAS, the property owner would maintain right-of-ways for the access to said utilities. and;

WHEREAS, the vacation of Fulmer Alley from 1-3 Campbell Avenue towards the end of Fulmer Alley would not be adverse to the best interest of the public welfare of the City of Johnstown, Pennsylvania

NOW, THEREFORE, BE IT ENACTED AND ORDAINED, by the City Council of the City of Johnstown, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

SECTION 1. That Fulmer Alley from 1-3 Campbell Avenue towards the end of Fulmer Alley in the 17th Ward of the City of Johnstown is hereby vacated as a public thoroughfare.

SECTION 2. That the City of Johnstown is not liable for any utility or sewer relocation cost or any reuse cost incurred by the property owner.

SECTION 3. All ordinances or parts of ordinances in conflict herewith be and the same are hereby repealed insofar as they conflict herewith.

SECTION 4. This ordinance shall become effective upon final Passage.

ORDINANCE NO. 5276

BILL NO. 30 of 2019

Introduced in Council September 11, 2019

AN ORDINANCE TO VACATE JONES PLACE FROM NAPOLEON STREET TO ROBB AVENUE IN JOHNSTOWN, PENNSYLVANIA, AS A PUBLIC THOROUGHFARE.

WHEREAS, the existing conditions of Jones Place do not allow for traffic to enter or exit the alleyway at either end due to overgrowth, and;

WHEREAS, through the ongoing Kernville Sanitary Sewer Project the City is currently under permit with PennDOT to replace disturbed curb ramps along Napoleon Street, and;

WHEREAS, PennDOT is acceptable to replacing the entrance of Jones Place with traditional curb and sidewalk if the alley is vacated, which in turn saves the costs associated with curb ramp replacement, and;

WHEREAS, the vacation of Jones Place from Napoleon Street to Robb Avenue would not be adverse to the best interest of the public welfare of the City of Johnstown, Pennsylvania

NOW, THEREFORE, BE IT ENACTED AND ORDAINED, by the City Council of the City of Johnstown, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

SECTION 1. That Jones Place from Napoleon Street to Robb Avenue in the 6th Ward of the City of Johnstown is hereby vacated as a public thoroughfare.

SECTION 2. All ordinances or parts of ordinances in conflict herewith be and the same are hereby repealed insofar as they conflict herewith.

SECTION 3. This ordinance shall become effective upon final Passage.
