

**CITY OF JOHNSTOWN, PENNSYLVANIA
ORDINANCE NO. 5320**

BILL NO. 12 of 2021

Introduced October 11, 2021

**AN ORDINANCE AMENDING THE ADMINISTRATIVE CODE OF THE CITY OF
JOHNSTOWN TO CONFIRM, REINSTATE AND/OR RESTORE SECTION 202.99;
GENERAL CODE PENALTY, COMPLICITY, EQUITABLE REMEDIES.**

WHEREAS, Ordinance No. 5283 adopted on February 12, 2020 was codified in a manner that indicated a repeal of Section 202.99 of the City of Johnstown Administrative Code in its entirety, as opposed to a repeal of language solely in regard to its application to inadvertent and/or previous instances of noncompliance with changes to the City's purchasing procedures; and

WHEREAS, Section 202.99 provides a penalty for violations of any of the Codified Ordinances in instances where no penalty is otherwise provided in the Codified Ordinances; and

WHEREAS, the City of Johnstown City Council wishes to confirm the application of Section 202.99 to the Administrative Code in order to provide said penalties and, to the extent necessary, restore and/or reinstate it as intended and applicable;

NOW THEREFORE, it is hereby ordained and enacted and adopted, as an amendment to the Codified Ordinances, as follows:

Section 1. Chapter 202.99 is hereby confirmed, and to the extent necessary, reinstated and shall apply as provided below:

**Chapter 202.99 – GENERAL CODE PENALTY, COMPLICITY, EQUITABLE
REMEDIES**

Whoever violates or fails to comply with any of the provisions of these Codified Ordinances, including any provision of any standard, technical or other code adopted by reference in these Codified Ordinances, and including any rule or regulation promulgated under authority of any such standard, technical or other code adopted by reference to these Codified Ordinances, or under authority of any other provision of these Codified Ordinances, shall pay a civil penalty of not more than three hundred (\$300.00) dollars for each offense. Unless otherwise provided, a separate offense shall be deemed committed each day during or on which a violation or noncompliance occurs or continues.

Section 2. All ordinances and resolutions or parts thereof in conflict with any provision of this Ordinance and/or the application of Chapter 202.99 are hereby repealed.


