#### PUBLIC COMMENT

- Mr. Vitovich stated the matter was discussed during executive session, and he could not comment further. Mr. Vitovich further desired to find out who started that rumor, and noted that would be a reason for that person to be removed from the Board. Mr. Vitovich suggested that Mr. DeBartola contact the CamTran Solicitor regarding the matter.
- Mayor Janakovic read into the record a letter addressed to Robert Ritter, Finance Director, from Joseph Martella, Jr., noting the appointment of Donnie Stanton as Commissioner of the Johnstown Collegiate Baseball League. Mayor Janakovic thanked Tony Crisafulli and Myron Markovitz who had helped with the AAABA for many years.

Mayor Janakovic noted the Point Stadium Banquet would be held on a Sunday in February.
