JOHNSTOWN CITY COUNCIL REGULAR MEETING MINUTES WEDNESDAY, OCTOBER 14, 2020

City Council met in a stated session for the general transaction of business. Mayor Janakovic called the meeting to order at 6:01 p.m.

Mr. Britt offered the invocation. The Pledge of Allegiance was recited.

APPROVAL OF MINUTES

Mr. Vitovich made a motion to approve the Regular Meeting Minutes of August 12, 2020 and Special Meeting Minutes of August 26, 2020. The motion was seconded by Mr. Capriotti and passed by the following vote:

PROCLAMATIONS, AWARDS, HONORS, RESOLUTIONS OF RECOGNITION:

Mayor Janakovic awarded three proclamations, including one proclaiming October 7, 2020 as Energy Efficiency Day and one naming Joyce Robley, author of the poem <u>January</u>, and Mike Gruber, author of the poem <u>The War is Over</u> as Official Poet Laureates of Johnstown.

He read the following proclamation into the record:

Whereas, Miss Jessica Gardner has rendered service to this community which deserves special recognition.

And Whereas, she was crowned Miss Wheelchair Pennsylvania 2021 by Ms. Wheelchair Pennsylvania Organization. Ms. Gardner has spent countless hours coordinating volunteer efforts and raising an awareness to people living with disability for the organization. Her dedication and passion to the work of this and other civic organizations has won for Ms. Gardner the respect of her fellow advocates.

Now Therefore, I, Frank J. Janakovic, Mayor of the City of Johnstown, on behalf of City Council and all our citizens am pleased to tender this certificate of recognition which I'll be awarding this Sunday to Ms. Jessica Gardner with our sincere thanks for her dedicated service to the welfare of our community.

Mayor Janakovic commented that Ms. Gardner has volunteered many hours with the ACRP and has helped many individuals and offered a special proclamation thank you to her.

PUBLIC COMMENT - AGENDA ITEMS ONLY:

Katie Kinka, 141 Franklin Street, Apartment One, Johnstown, thanked Council for the opportunity to work with John Dubnansky on amending the language of the existing ordinance permitting dogs in parks and playgrounds and the City's green spaces.

REPORTS:

CITY MANAGER:

John Trant, Jr., Interim City Manager, suggested that Council table the dog ordinance to allow continued work on coordinating enforcement between the ordinance as drafted and the Police Department.

MAYOR:

Mayor Frank Janakovic noted a very successful State of the City held at PNG Park to comply with COVID regulations and thanked Mr. Trant and Mr. Dubnansky and all those who attended.

Mr. Janakovic and Reverend King attended the recent Vision Together 2025 meeting.

He met with officials from New Castle regarding the types of City government.

He and Reverend King also attended a meeting regarding investment of the funds for Police, Fire and Public Works where questions regarding investments were answered.

Mr. Janakovic noted his attendance at a discussion regarding some possible development in the West End that will be shared in the future. He also attended

the Chamber of Commerce, Regional Partnership and JARI Growth Fund meetings.

CITY SOLICITOR

Elizabeth Benjamin, Esquire, City Solicitor, noted she would comment on matters as needed. An amendment will be offered for Bill No. 20 of 2020, No. 4 on the agenda.

CITY ENGINEER

Brandon Palmer, EADS Group, reported the Act 537 Plan is lingering in the background, and approval from PADEP was finally received for placing advertisement followed by a 30-day public comment period. He stated that copies would need to be placed at City Hall and the Greater Johnstown Water Authority and possibly the website to limit the amount of public entering those areas.

Mr. Palmer reported he is working with Public Works drawing up a formal scope of work for the Main Street East Parking Garage.

NEIGHBORHOOD LIAISONS

Mr. Capriotti had no report.

Mr. Britt had no report.

Mr. Arnone reported that as of September 30, 2020, the total population of the public housing communities was 2,566 and Section Eight voucher holders totaled 830, or 3,396 families. He noted that the Johnstown Housing Authority assists 45 percent of the people living in poverty level in the City of Johnstown.

Mr. Arnone reported that the City's population per the 2016 American Community Survey is 19,450 people, with 38.7 people living at the poverty level which equates to 7,527 people.

He reported that the Johnstown Housing Authority has completed the sanitary sewer work at all the public housing communities in the City and therefore, is in full compliance with the mandate required.

Mr. Arnone announced his appointment to the Greater Johnstown Water Authority and will report next month to Council.

Mr. Vitovich reported that Public Works has been trimming back trees on Von Lunen Road, replaced a collapsing wall on the AAABA field at Roxbury Park, continues to clean sewer lines and catch basins, and provide street sweeping City wide.

Mr. Vitovich stated the parking lot at the Berkley Hills Golf Course is in need of repairs and suggested the matter be looked at before someone gets hurt.

Mrs. Mock reported that the Roxbury Civic Group held a recent garage sale to raise funds for improvements at Roxbury Park.

She reported another successful year for The West End Improvement Group's community garden and the flower boxes on Route 56 which will be taken down in the near future.

With regard to the Roxbury Hockey Rink, Mrs. Mock noted that a woman from Greensburg read an article about the rink a while back and facilitated a meeting with the Executive Director of Public works in Pittsburgh who came to help work on the rink.

Mayor Janakovic reported funding is available for a splash park which will be located on Chestnut Street in the City's Cambria City section.

Reverend King thanked Mr. Dubnansky for visiting all the neighborhoods and having meetings with the residents. She noted the next meeting is Monday, October 19, at 6:30 p.m. on the first floor of the County Building for the residents and merchants of downtown. Monday, November 9, 6:30 p.m. a meeting will be held for the residents of Minersville and Cambria City at the VOMA building. Monday, November 16, a meeting will be held for the Hornerstown and Walnut Grove residents at the Middle School.

She referred to a youth survey available on the Vision 2025 website for review.

Reverend King thanked Interim Chief Miller, District Attorney Greg Neugebauer, Senator Wayne Langerholc and Council members who attended the recent police call-in forum regarding the policies and procedures of the Johnstown Police Department. She also thanked Mr. Campagna and his crew for their help.
