WHEREAS, community civic groups and members of Council want to expand recreational activities in the community for our youth as a means of addressing violence and drug issues, and

WHEREAS, more recreational facilities and activities were cited as a necessity by the Pennsylvania Department of Economic Development to be included in our revised Comprehensive Plan.

A RESOLUTION OF THE CITY COUNCIL, OF THE CITY OF JOHNSTOWN, PENNSYLVANIA, CAMBRIA COUNTY, PENNSYLVANIA, AUTHORIZING AND DIRECTING THE INTERIM CITY MANAGER TO SIGN AN AGREEMENT WITH DOREEN R. BABISH TO TRANSFER \$16,603.59 IN ESCROWED FIRE INSURANCE PROCEEDS RELATIVE TO THE REAL PROPERTY LOCATED AT 1127 VIRGINIA AVENUE IN JOHNSTOWN, PENNSYLVANIA.

WHEREAS, the Commonwealth of Pennsylvania enacted Act 98 of 1992 and Act 93 of 1994, amending the Insurance Company Law of 1921 to provide procedures for the payment of certain fire loss claims and has enacted amendments thereto; and

WHEREAS, the City of Johnstown adopted Ordinance No. 4710, passed finally February 8, 1995, which established procedures for the disposition of fire insurance proceeds and costs of removing, repairing or securing fire-damaged buildings; and

WHEREAS, Chapter 244.035 of the City's Administrative Code authorizes the City to enter into an agreement with the named insured for the transfer of fire insurance proceeds where some other reasonable disposition of the damaged property has been negotiated; and

WHEREAS, the real property located at 1127 Virginia Avenue in Johnstown, Pennsylvania and owned by Doreen R. Babish (hereinafter referred to as "Property"), suffered fire damage on October 24, 2016 and Allstate Insurance transferred fire insurance proceeds to the City; and

WHEREAS, the City currently retains \$16,603.59 in escrowed fire insurance proceeds and has not incurred any costs for the repair, removal or securing of the Property; and

WHEREAS, the Property was subsequently sold by Doreen R. Babish, the named insured, to Raymond Jastrzab on March 24, 2017 with title conveyed by special warranty deed; and

WHEREAS, the City desires to transfer the escrowed fire insurance proceeds to the Named Insured in light of the sale of the Property and Raymond Jastrzab's expressed intent to demolish the Property by December 1, 2018.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Johnstown, that the City Manager is hereby authorized and directed to execute, on behalf of the City of Johnstown, an agreement with Doreen R. Babish to transfer the escrowed fire insurance proceeds retained by the City in connection with the real property located at 1127 Virginia Avenue in Johnstown, Pennsylvania.
