WHEREAS, The City of Johnstown Home Rule Charter, Article X Financial Procedures states in § 11.10-1009. Lapse of Appropriations.

Every appropriation, except an appropriation for a capital expenditure, shall lapse at the close of the fiscal year to the extent that it has not been expended or encumbered. An appropriation for each capital expenditure shall continue in force until the purpose for which it was made has been accomplished, or the proposal has been discontinued by the Council; and

WHEREAS, The City of Johnstown Home Rule Charter, Article X Financial Procedures states in § 11.10-1010. Administration of the Budget.

(d) Transfer of Appropriations. At any time during the fiscal year the Manager may transfer part or all of any unencumbered appropriation balance among programs within a department, office or agency and, upon written request by the Manager, the Council may by resolution transfer part or all of the unencumbered appropriation balance from one department, office, or agency to another Any transfer made by the Manager shall be reported to the City Council at the next Council meeting, and

WHEREAS, pursuant to City of Johnstown Home Rule Charter, Article X Financial Procedures, the 2018 Transfer of Funds executed by Resolution No. 10198 on August 14, 2019, and any other 2018 Transfer of Funds executed by the City Manager under provisions of (d) Transfer of Appropriations, whereby "At any time during the fiscal year the Manager may transfer part or all of any unencumbered appropriation balance among programs within a department, office or agency", are invalid and non-complaint with Home Rule Charter, Article X Financial Procedures states in § 11.10-1010. Administration of the Budget, and

NOW THEREFORE BE IT RESOLVED, that Resolution No. 10198, passed on August 14, 2019 is hereby REPEALED, and the City Manager and the Director of Finance are directed take all required corrective accounting actions to reverse any and all 2018 Transfer of Funds authorized by Resolution No. 10198, and any and all 2018 Transfer of Funds executed by the City Manager from January 1, 2019 to date, as unencumbered appropriation balance among programs within a department, office or agency, and not subject to authorization by Resolution of City Council.
