JOHNSTOWN CITY COUNCIL REGULAR MEETING MINUTES WEDNESDAY, NOVEMBER 18, 2020

City Council met in a stated session for the general transaction of business. Mayor Janakovic called the meeting to order at 6:05 p.m.

Reverend King offered the invocation. The Pledge of Allegiance was recited.

The following members of Council were present for roll call: Charles Arnone, Ricky Britt, Michael Capriotti, Mayor Frank Janakovic, Reverend Sylvia King, Marie Mock, David Vitovich (7).

John Trant, Interim City Manager; Elizabeth Benjamin, Esquire, City Solicitor; Robert Ritter, Finance Director; Brandon Palmer, EADS; John Dubnansky, Director of Economic Development; Chad Miller, Interim Police Chief; Robert Statler, Fire Chief; and Bruce Graham, Gibson-Thomas Engineering, were also present.

Mayor Janakovic noted that an Executive Session was held on October 21, 2020, regarding personnel matters. Prior to this meeting, an Executive Session was held with regard to personnel and litigation.

PUBLIC COMMENT - AGENDA ITEMS ONLY:

John DeBartola, 1197 Bedford Street, Johnstown, addressed some budget items. He stated he believed in "supporting our police" and police presence. Mr.

DeBartola asked Council to reconsider amending the budget to include a budget for the City of Johnstown Ethics Board given some conflicts of interest.

Larry Blalock, 423 Main Street, Johnstown, addressed Council regarding increased police funding. He stated there was a greater need for a healthcare advocate and mental health suicide response team for those struggling with mental health issues. He inquired as to why a meeting requested by Put People First! had not been responded to and would the hiring of more police solve the problem of abuse. Mr. Blalock asked the City to consider the needs of the people during the budget process.

Lonnie Rietscha, 121 Davis Street, Johnstown, stated, as a City taxpayer who sees drug activity occurring on an almost daily basis in his community, he totally disagreed with the stand of Put People First! He suggested more dogs and more police presence.

REPORTS:

CITY MANAGER:

John Trant, Jr., Interim City Manager, referred Council members to a detailed organizational chart per their request.

MAYOR:

Mayor Frank Janakovic noted his opportunity to attend a number of neighborhood meetings, including the Hornerstown/Walnut Grove/Moxham, Cambria City/Minersville, and the West End/Coopersdale, where he stated those in attendance provided good feedback.

He noted his attendance at the recent Veteran's Day Parade, the Vision Together 2025 meeting and the Jari Growth Fund.

Mr. Janakovic provided a presentation for the proclamation of the two poet laureates, who were nominated to promote poetry throughout the area.

The Mayor and other Council members participated in recent City Manager interviews. He attended a virtual Executive Summit in the City and participated in a Zoom assembly with the third graders at Ferndale Elementary School.

He reminded all of the upcoming Stroll Down Main Street event.

With regard to Put People First!, the Mayor noted receiving numerous letters with no names, signatures, phone numbers or addresses to receive a response. He offered to participate in a meeting with the group.

Mr. Janakovic explained that mental health is covered at the County, State and Federal level. The City is not licensed to be a mental health provider and involved in those types of services. He did remind all of the availability of organizations such as Crisis Interventions and Social Services. He noted a clear distinction between funding for the two services. A grant for the police would be specific to the police and not available for the crisis or mental health services. He requested Mr. Ricci or Mr. Blalock contact him with regard to setting up a meeting.

CITY SOLICITOR

Elizabeth Benjamin, Esquire, City Solicitor, noted two amendments to be addressed by Council, one for a First Read ordinance and the other a Resolution. Any questions regarding those matters would be addressed during that time.

CITY ENGINEER

Brandon Palmer, EADS Group, reported the Act 537 Plan completed its 30-day window with no comments. He noted, "We are very close to getting the system out from under the City over to the GJWA."

NEIGHBORHOOD LIAISONS

Reverend King noted her attendance at some community meetings sponsored by Mr. Dubnansky.

She noted the United Neighborhood Group will resume community meetings in the spring.

Reverend King stated Christ Centered Community Church will host its 11th Annual Community Christmas dinner, which will be modified due to COVID.

Mrs. Mock reported that the West End Improvement Group put the flower boxes away and thanked the Keystoners for their assistance in cleaning and hauling them away.

She noted fundraiser events will be held during the winter.

Mr. Vitovich reported on Public Works work on portions of Derby Street from Franklin Street to Roxbury Avenue.

Leaves were being cleaned up with the City's leaf vac, and inlet repairs were completed.

He stated the houses were up in Central Park and ready for the Christmas Stroll event on November 20, 2020.

Mr. Arnone provided updates on statistical information related to the population of the public housing communities. He stated, as of October 21, 2020, the total population of the public housing communities was 2,611. Section Eight voucher holders totaled 831, for a combination of 342 residents.

He noted upcoming projects included door replacement at the Coopersdale and Oakhurst Homes.

As a representative of the Greater Johnstown Water Authority, Mr. Arnone stated the purchase of the sewer collection system was finalized on September 9, 2020. A funding project will include \$4,890 in low interest loans and \$6,517,110 in grant funding.

He stated the CDBG project will be advertised for bids as of November 20, 2020. 800 pressure tests and 10 manhole covers were completed.

The Greater Johnstown Water Authority obtained \$930,000 in grant funding for the North Fork Dam reconstruction project. He indicated the design for the project was under review by the PA DEP.

Mr. Arnone commented that the GJWA received an award from the DEP for improving water quality throughout the distribution system. He noted the Authority disconnected 25 sewer lines to raze buildings.

Councilman Arnone indicated a red, white and blue mailbox was installed in front of the American Legion for disposal of American flags.

He noted the 11 GJWA Board members, including three from Southmont, four from Johnstown and four from Westmont.

Mr. Britt reported the sewer work was near completion in Old Conemaugh Borough and paving should soon commence.

He noted the tentative date for a ceremony renaming the Hickory Street Bridge to the Carlton Haselrig Bridge would be November 28, 2020, at 1:00 p.m.

Mr. Capriotti noted his attendance at the Discover Downtown Partnership Trunk or Treat Night held on October 24, 2020.

He reiterated that a Hometown Christmas Stroll would be held on November 20, 2020, from 6:00 p.m. to 7:00 p.m. Mr. Capriotti applauded Discover Downtown for their efforts to "shine a light on the City."

Councilman Capriotti commented on the condition of Osborne Street and McKinley and Boyd Avenues in the Eighth Ward. He stated the streets were starting to "heave pretty significantly where sewer work was done," similar to what happened on Franklin and Plainfield Streets.

Mayor Janakovic indicated that money was allocated for those projects in the budget every year, which had not been before. Mr. Trant noted that \$800,000 was budgeted for these types of projects. There was further discussion regarding the matter.

COUNCIL UPDATES:

- Mr. Trant explained that the Ethics Board provided a detailed outline of needed budgetary items for Council's consideration, which totaled \$315,000 for 2021. He noted the request included \$60,000 for legal counsel, \$60,000 for investigators, \$65,000 for clerical staff, \$10,000 for clerical equipment, \$120,000 for other expenses related to clerical services such as court reporters, \$70,000 for rent for space to work and meet in, and \$50,000 for a vehicle. He stated \$15,000 had been budgeted for the Ethics Board.
- Ms. Benjamin explained that the Ethics Board was specific to the City, but it rules on similar areas and reiterates the same standards that are within the State Ethics Act for public officials and employees. She noted there were some provisions making reference to violations of other City provisions or ordinances relating to those topics, but it directs on the same topics, a conflict of interest between elected officials with respect to the award of contracts or acceptance of gifts or political contributions.

Ms. Benjamin further explained that the City's Ethic Board would investigate on a local level but has the same duties, the same obligations and responsibilities as the State Ethics Commission would have upon receiving the same complaint.

Counsel stated the City's ordinance, which Council is now free to amend, was adopted via voter referendum originally and ratified by Council once adopted by the voters. She noted the ordinance was the subject to a two-year delay and any opportunity to amend. The ordinance could now be amended or altered. One difference noted was the timeline to complete investigations, issue advisory opinions, and conduct investigations. There was further discussion regarding the matter.

Ms. Benjamin explained that the Ethics Board was created via ordinance. Council has the power to take action to repeal that ordinance, but such action could be accomplished at this meeting.

The City Manager and Ms. Benjamin were directed to prepare an ordinance implementing the repeal and the abolishment of the Board. Ms. Benjamin noted the ordinance would appear on next month's agenda.
