

JOHNSTOWN CITY COUNCIL  
REGULAR MEETING MINUTES  
Wednesday, March 13, 2019

City Council met in a stated session for the general transaction of business.  
Mayor Frank Janakovic called the meeting to order at 6:00 p.m.

Reverend Sylvia King offered the invocation. The Pledge of Allegiance was recited.

Mayor Janakovic noted an Executive Session was held prior to the commencement of the regular meeting with regard to litigation and personnel.

The following members of Council were present for roll call:

Mr. Britt was absent due to medical reasons.

George Hayfield, City Manager, Elizabeth Benjamin, Esquire, City Solicitor, and  
Jonathan Rosenthal, Economic Development Director were also present.

APPROVAL OF MINUTES

Mr. Vitovich made a motion to approve the January 16, 2019 Public Hearing and  
January 16, 2019 Regular Meeting Minutes. The motion was seconded by  
Mrs. Mock.

City Clerk, Nancy Cushing stated the January 16, 2019 Regular Meeting Minutes and  
February 13, 2019 Regular Meeting Minutes would need to be tabled due to  
incorrect numbering of resolutions.

Attorney Benjamin explained that the January 16, 2019 Public Hearing verbatim  
transcript did not contain resolution numbers and were improperly adopted  
before numbers were assigned. She noted minutes would reflect the resolution  
numbers and presented at the next meeting for adoption.

Mrs. Mock made a motion to table the adoption of the January 16, 2019 and February  
13, 2019 Meeting Minutes. The motion was seconded by Mr. Vitovich and  
passed by the following vote:

#### REPORTS

##### CITY MANAGER

George Hayfield, City Manager, reported on applying for a DCED grant to upgrade the telephone and computer systems at City Hall and the Public Safety Building.

Civil Service Rules and Regulations in the process of being updated will likely be done by the end of the month and brought to Council for approval.

Mr. Hayfield reported that two police officers had been hired and will start by the first week of April. He noted the addition of the two officers would bring the police department to full staffing with 38 officers. Mr. Hayfield noted the fire department received ten applications for two positions that would bring that department to full staffing with 28 firefighters.

Mrs. Mock inquired whether the Atlantic Broadband contract had been reviewed. She stated residents are requesting other options.

An unidentified gentleman entered the meeting requesting to sign up for public comment, stating he thought the meeting was being held at City Hall instead of the Public Safety Building.

Mrs. Stanton made a motion to allow the man to speak. The motion was seconded by Mrs. Mock and failed by the following vote:

Yeas: Mrs. Mock, Mrs. Stanton (2).

Nays: Reverend King, Mr. Vitovich, Mr. Williams, Mayor Janakovic (4).

Mayor Janakovic apologize noting that it would be setting a precedent if he was allowed to speak this evening, that he would need to sign up prior to the meeting date in order to be placed on the agenda. He was welcomed to stay and talk to any council member at the end of the meeting.

There was further discussion regarding the Atlantic Broadband contract.

Mr. Williams made a motion directing the City Manager to seek RFPs for cable service providers. The motion was seconded by Mrs. Stanton.

The Solicitor explained that the City Manager could investigate what the current contract states and what the options are.

Mr. Williams amended his motion directing the Solicitor and City Manager to investigate the matter further as to what steps would need to be taken to secure a request for proposals in accordance with the FCC and to report back as quickly as possible. The motion was seconded by Mrs. Stanton and passed by the following vote:

Mr. Williams stated the transfers that the City Manager was to initiate, one dated 12/31/2018 and the other dated 2/2019, would be in direct violation and noncompliant with the Home Rule Charter and cited those portions of the Home Rule Charter pertaining to the transfers. There was further discussion regarding the matters.

Mrs. Stanton inquired if the City was "on target" for having the violations corrected by May 7, 2019 at the Public Safety Building. Mrs. Mock stated she spoke with the Public Works Director who indicated that work would be starting soon in the basement. Mr. Hayfield stated the corrections would be made by the target date.

Mrs. Stanton inquired about the status of a complaint from a resident regarding a sewage backup. Mr. Hayfield noted that matter was investigated and it was not the City's sewage line. Mr. Vitovich explained that Public Works would conduct dye testing and open the lines once a week. He stated Public Works does a great job keeping these lines open.

The City Manager suggested that the Public Works Director be contacted regarding the matter.

Mrs. Stanton made a motion requesting Department heads attend City Council meetings. The motion was seconded by Mrs. Mock and passed by the following vote:

Yeas: Mrs. Stanton, Mr. Williams, Reverend King, Mrs. Mock (4).

Nays: Mr. Vitovich, Mayor Janakovic, (2).

Mr. Williams commented that if there were an issue on the agenda that pertained to Public Works or Finance or other department, that department head should be present.

Mrs. Stanton commented on a City-owned lot at the corner of Bond and Grove Avenue that contained an abandoned vehicle, dry asphalt, garbage, weeds, litter, broken concrete wall, wooden posts, plywood and tree limbs. She stated the matter was previously reported in September, October and December of 2018 and January of 2019 and needs to be addressed. There was discussion regarding the condition of a laydown site in Moxham used by sewage contractors not being returned to its previous condition. The City Manager was requested to provide a list of all contractors/owners of the laydown sites in order to be contacted regarding the matter.

## MAYOR

Mayor Frank Janakovic noted his attendance at the Ice Fest at PNG Park. He also attended the Community Foundation Ribbon Cutting Ceremony at the Ameriserv Building on Franklin Street. The Foundation allocated over \$6 million in grants last year.

He attended the grand opening of Flood City Flooring and thanked the Schrengosts for picking downtown Johnstown to start a business.

Kevin Stevens was guest speaker at the recent Chamber dinner who spoke about his fight with drug addiction.

Awards were given to Discover Downtown, Johnstown Redevelopment Authority, and the Greater Johnstown School District that were recognized for their community work.

Mayor Janakovic presented at the recent State of the City at Aces Lounge. Mr. Hayfield, Mrs. Mock and Reverend King, Melissa Radovanic and Wally Burlack also presented.

The Mayor attended the recent Roxbury Bandshell Fundraiser and thanked Mary Borkow for her dedication and hard work to preserve the bandshell and provide free concerts throughout the summer.

Mr. Janakovic congratulated the organizers of the recent Mardi Crawl held downtown.

He noted his attendance at the recent Boy Scout/Harry E. Mangle Awards Dinners.

Mayor Janakovic thanked Steve St. John, former general manager of the War Memorial for his service. Mr. St. John has accepted another position.

#### CITY SOLICITOR

Solicitor Elizabeth Benjamin noted no report other than discussion on upcoming agenda items.

Mrs. Stanton made a motion that a letter signed by each Council member be sent to Mrs. Rager officially thanking her husband, Shawn Rager, for his 23 years of service as a police officer and retiring his badge number. The motion was seconded by Mr. Vitovich and passed by the following vote:

Mrs. Stanton inquired about the use of the City's seal on a flyer sent out by the Governmental Action Committee regarding the State of the City Address. Ms. Benjamin will review the matter.

There was discussion regarding amending Bill No. 4 of 2019 on the agenda regarding the transfer of property on the Inclined Plane hillside.

#### CITY ENGINEER

No Report.

Mrs. Stanton referred to the EADS March report for discussion of sewage work that was completed but pressure testing was not done, whether property owners would be fined and how much, and how the City would be paying back PennVEST loans for the sewage project.

Mayor Janakovic reiterated that if compliance was not met by 2022, the fines will increase significantly to up to \$10,000 a day. He noted that JRA loans are available. Mrs. Mock suggested that the matter be reviewed further to provide answers to questions from the City residents. Mrs. Stanton suggested changing the sewage mandate and contacting DEP regarding matter.

### NEIGHBORHOOD LIAISONS

Mrs. Mock reported the West End Improvement Group spring cleanup was scheduled for Saturday, April 6, 2019.

Donations are being accepted for a Trash to Treasure Sale which will be held in May.

The Kernville cleanup was scheduled for April 13, 2019.

The recreation committee was working with the City to provide input regarding issues at the Point Stadium.

The Stackhouse Park dam that flooded some homes in the West End last year was full of trees, shrubs, et cetera, and its purpose was not being met. Representative Burns office was working to obtain a DCED CFA Flood Mitigation Program Grant to dredge and make repairs to the dam.

The Community Foundation has committed \$45,500 towards renovation of the skating rink at Roxbury Park. Reverend King noted that she and Mrs. Mock did a presentation on recreation at the recent State of the City event and were able to raise the \$15,000 needed which would be matched by \$15,000 for a total of over \$75,000 towards the renovation project. Reverend King told the

City Manager he could now "start putting out RFPs" for the project. She stated the United Neighborhood Group coupled with Coaches for Kids Coach Penna would be working with kids at the playgrounds this year. Monitors would be located at the Park Avenue, Wood Street, Roxbury Park playgrounds.

Reverend King noted the United Neighborhood Meeting was scheduled for Thursday, March 21, 2019 at 5:30 at Christ Centered Community Church. The Kernville meeting will be held on March 28, 2019 at 5:30.

Reverend King noted that Friday, May 3, 2019, at 5:30 the Fifth Annual Unity Peace Walk would be held followed by a fellowship meal at the Greater Johnstown High School cafeteria.

Mr. Williams referred to the packet for discussion of a report of parking scofflaws which totaled \$16,710, and noting 69 percent from the downtown business area. Ms. Benjamin will check on the Statute of Limitations for parking violations. There was further discussion regarding review of the ordinance, how many of the tickets are expired and what action could be taken to collect that revenue.

Mr. Williams referred Councilmembers to his March 4, 2019 letter for further discussion of the FJP Conference Center, 301 Napoleon Street. He noted that money was being requested for carpeting in the amount of \$115,000 plus an additional \$10,000 for a projector.

Mr. Williams commented that in 2017, Arch Liston who was City Manager at that time, noted that carpet money was set aside in the budget but shortly after was transferred out. Mr. Williams inquired as to how Council planned on meeting this obligation, and stating that if Crown does not obtain a response from the City within 20 days, they will consider it approved.

The City's responsibilities are outlined in the lease. Melissa Komar, a former City Manager, was to have scheduled a meeting with Michael Barletta at Crown that did not occur. Mr. Williams commented this carpet obligation had been ongoing since 2010.

Mrs. Stanton made a motion requesting that the City Manager or City Solicitor contact Crown's representatives for the purpose of renegotiating the lease. The motion was amended by Mr. Williams to requesting that the City Solicitor contact Crown's Counsel to discuss renegotiation of a lease with more favorable terms. The motion was seconded by Mr. Williams.

It was noted the lease expires in 2023. Mrs. Mock referred to it as "the worst contract in the world".

Mr. Williams acknowledged that he was a Councilmember at the time the lease was negotiated and that he did vote in favor of the contract.

The motion passed by the following vote:

Mr. Vitovich reported on the Public Works attempting to keep up with cold patching holes as the weather permits and handling miscellaneous jobs/repairs that are needed. He stated Public Works can be contacted at 533-2089 to report potholes.

Mrs. Stanton noted the Change for Johnstown Facebook group organized an Easter basket collection to benefit the needy in the area. The baskets can be dropped off at the Park Avenue United Methodist Church.

She noted complaints had been received regarding the Christmas decorations at the Roxbury Bandshell. She stated complaints had also been received regarding garbage pickup. Mrs. Stanton reminded City residents to make sure the stickers are visibly displayed. She noted the City Manager could be contacted at 533-2001 to report garbage being picked up on a property without a sticker being properly displayed.

Mrs. Stanton made a motion requesting that the City Manager conduct an investigation on the condition of the trees at Roxbury Park. The motion was seconded by Mr. Williams and failed by the following vote:

Yeas: Mrs. Stanton, Mr. Williams (2).

Nays: Mayor Janakovic, Reverend King, Mrs. Mock, Mr. Vitovich (4).

Mrs. Mock requested that someone check on the condition of the trees at Roxbury Park. It was noted that some of the playgrounds in the City also had trees that are following over or decayed.

ORDINANCES FOR FINAL READ

BILL NO. 3 OF 2019, AN ORDINANCE OF THE CITY OF JOHNSTOWN, PENNSYLVANIA, AUTHORIZING THE ESTABLISHMENT OF A PROPERTY TAX EXEMPTION FOR CERTAIN UNDERUTILIZED, BLIGHTED OR DETERIORATED INDUSTRIAL, COMMERCIAL OR OTHER BUSINESS PROPERTY; DEFINED ELIGIBLE AREAS; SETTING A MAXIMUM AMOUNT; AND AN EXEMPTION SCHEDULE; AND PROVIDING A PROCEDURE FOR SECURING AN EXEMPTION.

Mr. Vitovich made a motion to approve. The motion was seconded by Mrs. Mock.

Mrs. Stanton noted that she and Mr. Williams were not invited to a special meeting held on February 27, 2019 and asked why neither she nor Mr. Williams did not receive a notice or letter advising them of the meeting. Mrs. Mock noted that the meeting was titled a special meeting in error and that with the exception of Mr. Williams, emails were sent regarding the matter. There was further discussion. Mrs. Stanton requested to be excluded from group emails, that notices or letters be hand delivered or mailed to her.

Mrs. Stanton commented she was completely against the ordinance and opposed to any tax exemption due to the City's distressed status.

Mr. Rosenthal explained there are residential properties within a defined area, that the abatement was the increase for a certain period of time that is meant to be an incentive to make a new investment that decreases over ten years. At the end of the ten years, the full amount would be paid. He further explained that the LERTA as proposed for Moxham was new, but the formula was exactly the same as it pertains to downtown. There was further discussion regarding the LERTA program.

Mr. Williams called for the question.

The motion passed by the following vote:
