JOHNSTOWN CITY COUNCIL REGULAR MEETING MINUTES WEDNESDAY, MAY 13, 2020 VIDEOCONFERENCE

City Council met via videoconference in a stated session for the general transaction of business. Mayor Janakovic called the meeting to order at 6:06 p.m.

Reverend King offered the invocation. The Pledge of Allegiance was recited.

The following members of Council were present for roll call:

APPROVAL OF MINUTES

Mr. Arnone made a motion to approve the Regular Meeting Minutes of March 11, 2020; Workshop Minutes of April 1, 2020; Regular Meeting Minutes of April 15, 2020; Public Works Session of April 15, 2020; Workshop Minutes of April 27, 2020. The motion was seconded by Mr. Vitovich and passed by the following vote:

<u>PUBLIC COMMENT - AGENDA ITEMS ONLY:</u>

- Mr. Trant explained all public speakers would be called alphabetically and asked to provide their names and addresses for the record.
- John DeBartola, 1197 Bedford Street, Johnstown, addressed concerns regarding Resolution No. 7, the Atlantic Broadband cable franchise, and questioned why Council would vote for no more televised City Council meetings. He had

concerns regarding the Conrad Building resolutions and questioned how the building would be demolished while keeping the river wall intact.

Mr. DeBartola discussed Bill No. 9 regarding connection to the sanitary sewer system. He stated, "Council was talking out of both sides of their mouth on this." He stated found it interesting at this time of pandemic that Council was doing this and encouraged a "no" vote on the resolution.

He expressed concerns with regard to Resolutions 13 and 14, which addressed the coronavirus, and questioned how the COVID-19 monies would be spent.

Charlene Stanton, 184 Sell Street, Johnstown, addressed Council by noting her belief that this meeting was a violation of the Pennsylvania Open Meeting Sunshine Act and provided an explanation of her comment.

She noted Bill No. 7 would authorize business exemptions and deductions. She requested the same consideration be given to residents by extending the discount period until August and extending the face value deadline for the City's real estate taxes.

Mrs. Stanton addressed concerns regarding Bill No. 9, which seeks to amend the Sanitary Sewer Ordinance, and asked Council to consider the financially distressed property owners due to COVID-19 by extending sewage compliance deadlines, instead of fining for noncompliance. She indicated the Consent Order between the City and DEP contains a provision that allows deadlines to be extended due to circumstances beyond its control. She inquired whether anyone from the City had contacted the DEP regarding this matter.

REPORTS:

CITY MANAGER

John Trant, Jr., Interim City Manager, noted for the record that the meeting notice for tonight included both a computer link and phone conference line for public participation. He further indicated the conference line was being recorded. A copy of the recording would be posted to the City's website, along with the draft meeting minutes as soon as they were available.

He referred Council to an updated spreadsheet to track communication efforts with respect to the sewer deal.

Mr. Trant thanked staff for adapting to COVID operations and indicated the department directors had been working diligently to implement guidance provided to keep staff and public safe.

MAYOR

Mayor Frank Janakovic read the following statement into the record: On May 7, 2020, the United States Environmental Protection Agency awarded the City of Johnstown a \$600,000 grant to help deal with environmental issues on properties throughout the City. The funding will be used toward environmental assessments and remediation of Brownfield properties that once were home to industrial activity. Addressing environmental issues is key in developing property and creating new jobs in the City. The City is partnering with the Cambria County Redevelopment Authority and the Johnstown Redevelopment Authority to complete this program. No local funding is required as part of this grant. Work will begin on this program this summer.

Mayor Janakovic added that either in 2016 or 2018 the City received \$400,000 for similar projects throughout the City. Due to the successes of how those monies were used throughout the City, the City was awarded the EPA grant. He stated the City received many accolades with that, "which really shows what we're doing with Johnstown." Senators and other legislators were on the call to congratulate the City on its work with the Brownfields and throughout the region and county.

Mayor Janakovic also read into the record the following: Over the past several months, he and Council had engaged in review of proposed transactions and an asset purchase agreement that would be brought to Council for a future vote. More recently, we've had informational sessions with our professionals discussing particular provisions of the agreement, how they will impact our community and businesses. We would now like to begin the public education and engagement portion of this process. We invite all interested members of the public to view on the City's website the section entitled, Proposed Sewer Sale. There you will find summary information, some presentations that were made to Council and an opportunity to post questions. We will take questions through the middle of June and on June 10 Council will host a public hearing for public comment. We will hold another public hearing on June 17. After that public hearing it is the intention of City Council to deliberate on the proposed transaction and put it up to a vote.

Mayor Janakovic commended the groups and organizations, as well as City employees, for the paving work and improvements done on Franklin and Napoleon Streets and to Council for committing to curb-to-curb paving.

CITY SOLICITOR

Elizabeth Benjamin, Esquire, City Solicitor, had no report. She offered to be available to answer questions regarding agenda items.

She explained the advertisement for the meeting phone number correction was reviewed, and it was compliant with provisions adopted by the General Assembly to address the manner in which political subdivisions hold meetings during the pandemic and while operating under a state emergency. It provides that remote meetings should be advertised on the City's website or through the newspaper with the greatest extent of advance notice as practicable. The City updated its website in advance of this meeting and, likewise, published the correction to the access information as soon as possible, given the fact the newspaper circulation was currently been suspended on Tuesday. The meeting was deemed compliant with the adjusted requirements identified during this pandemic.

CITY ENGINEER

Steve Sewalk, EADS Group, referred Council members to his engineering report for review.

He noted the Woodvale and Oakhurst laterals were closed out. The work on the Morrellville and Cambria City areas was being closed out.

Paving in the Kernville area had been completed, except for some minor punch list items. Mr. Sewalk noted enough money was left in the budget to award No. 2 for about \$600,000, and he would be working with PennVEST and DEP on the matter.

Construction was underway and roughly 5 to 10 percent complete in Old Conemaugh Borough. The Fairfield Avenue project had been underway for a couple weeks, with side streets as well as the City section of the project being completed.

The PennVEST application was submitted for the Central Business District with the award sometime during the July time period.

In compliance with the Consent Order, compliance letters were sent out to the Moxham Phase Two area.

COUNCIL UPDATES/NEIGHBORHOOD LIAISONS

Mrs. Mock had no report.

Mr. Capriotti had no report.

Mr. Arnone reported no change in the operations of the Housing Authority. All business was still being conducted by phone, email, fax or mail. All in-person service was still suspended. He noted, as Cambria County moves into the Yellow Phase on May 15, 2020, the Johnstown Housing Authority will slowly increase the number of hours working in the office. Currently office personnel were in the office on Monday and Wednesday. Beginning the week of May 18, 2020, Friday will be incorporated into the schedule.

Mr. Arnone indicated effective May 1, 2020, contractors will resume all outside construction work. JHA will continue to monitor the COVID situation and determine when inside work can resume. Mr. Arnone stated the health and wellbeing of the staff, residents, and community are of the utmost priority to the JHA.

Mr. Vitovich reported Public Works had been patching potholes and was starting to use hot asphalt since the middle of April, running the street sweeper Monday through Friday, cleaning gravel from sidewalks and highway medians. He noted a repaired wall on a basketball court was painted, and the third and fourth floors of the Public Safety Building are being painted. Also, yard waste was getting picked up, lights under the underpass were being changed to LED, and grass was being cut at all playgrounds. Mr. Dubnansky was working on an agreement with the contractor regarding demolition work on Fairfield Avenue, which should soon commence.

Reverend King had no neighborhood report, but she announced on Thursday, May 14, 2020, from 1:30 until 3:00 boxes of produce would be distributed at the Galleria Parking Lot near Sears. She stated another food giveaway would be held on Saturday, May 16, 2020, at the Beulah Church.

Mr. Britt had no report.

Regarding the Tire Clinic in Coopersdale, John had contacted several tire recycling companies. One from Hollidaysburg provided the best pricing to remove the tires from the business. Trailers would soon be dropped off at the site, and Public Works would assist in loading those trailers. The cost of the project was

approximately \$3,200, and the property would be liened since all efforts to reach the owner have been exhausted.

Mrs. Mock commented on a call from a resident regarding petitioning the DEP to push the sewer compliance timeline back. It was noted that this would be discussed further when a resolution concerning the matter was discussed later in the meeting.

Mr. Vitovich made a motion to approve the ordinance. The motion was seconded by Mrs. Mock.

Mayor Janakovic inquired if the timeframe could be extended and whether it would be the City's responsibility or that of the GJWA if their proposal was accepted. Mr. Trant explained, if the sewer sale does proceed, the liability for the Consent Order shifts entirely to the buyer or purchaser. If the sale does not proceed, the City would be working with DEP to try to push the deadline further due to COVID.

Mr. Dubnansky explained this ordinance was not intended to deal with private lateral repair but intended to make sure that all residents and businesses were tapped into the system, regardless of whether or not there was a sewer sale.

Attorney Pape explained this was an existing ordinance, and the only change to be made was to change the name of the City to the owner or purchaser of the sewer collection system. Once a 12-notice was provided, the property owner would have 12 months to comply before enforcement action was taken.
