

JOHNSTOWN CITY COUNCIL
REGULAR MEETING MINUTES
Wednesday, May 8, 2019

City Council met in a stated session for the general transaction of business.

Mayor Frank Janakovic called the meeting to order at 6:00 p.m.

Reverend Sylvia King offered the invocation. The Pledge of Allegiance was recited.

The following members of Council were present for roll call:

George Hayfield, City Manager, Elizabeth Benjamin, Esquire, City Solicitor, Robert Ritter, Finance Director, were also present.

APPROVAL OF MINUTES

Mr. Vitovich made a motion to approve the March 13, 2019 Regular Meeting Minutes. The motion was seconded by Mrs. Mock and passed by the following vote:

PROCLAMATIONS, AWARDS, HONORS, RESOLUTIONS OF RECOGNITION

The Roxbury Civic Group presented the City with a check in the amount of \$6,000 to be used for backstops at Roxbury Park. It was noted that nearly \$700 has been raised for the rink. A cleanup will be held at the park on May 18. Mayor Janakovic, on behalf of Council and the City, expressed appreciation and thanked the group for their efforts.

Proclamations for approval, Mayor Janakovic noted the 30th Anniversary of the ACRP this Saturday, May 11, 2019. A Military Spouse proclamation will be presented on Friday, May 10, 2019.

PUBLIC COMMENT - AGENDA ITEMS ONLY

Tasha Adams, 3798 Menoher Boulevard, on behalf of You in Flood City, a local nonprofit, presented before Council regarding adoption of a City flag. She asked Council to consider adoption of one of three flags presented.

REPORTS

CITY MANAGER

George Hayfield, City Manager, reported a flood wall had collapsed on Sam's Run in the Moxham area. He noted that replacement of that section of wall will cost \$475,000 and the funding was yet to be decided.

Mr. Hayfield reported that the City has complied with all work requested with regard to the Public Safety Building, including replacement of heating units on the second and third floors, and new filters and ceiling tile.

\$180,000 from the insurance company will be placed in escrow for demolition of the Fairfield Avenue building that had burned last December. Demolition of the building was scheduled to begin before the end of May.

The City Manager reported that an inspection of Roxbury Park's playground yielded no safety issues.

Mr. Hayfield noted he had recently met with a representative from Keep Pennsylvania Beautiful with regard to installation of surveillance cameras at Roxbury Park.

He reported no response has been received from the Counterdrug Drug Task Force with regard to an application that was submitted.

Substantial work has been completed at the Point Stadium, including replacement of home plate with turf, replacement of two portable pitching mounds, batting cage, and painting of dugouts. He noted that Hiram G. Andrews will be constructing 40 wooden lockers for each locker room.

Mr. Hayfield reported that EADS has submitted a grant for St. Clair Run in the amount of \$475,000. He noted to have the dam dredged would cost approximately \$400,000.

Mrs. Mock contacted the Western Pennsylvania Conservancy which will send an interactive map and program. She asked if Public Works could work with EADS on the mapping to make sure trees are updated.

Mr. Hayfield noted a \$275,000 grant for drainage work, backstops on two baseball fields and handicapped parking at Roxbury Park. A second grant between the amount of \$250,000 to \$275,000 would be applied towards playground updates and updates to other areas.

Mr. Vitovich commented that the top soil that remains after the Stackhouse Park dam was dredged could be screened and sold. He suggested a location be found to store the soil.

Mrs. Stanton inquired if the resolution to repair the sidewalks at Roxbury Park was tabled, that if it was, she suggested the agenda be amended to include that for tonight's meeting.

Mrs. Stanton had discussion regarding the length of time code complaints are responded to. She provided a list of complaints for Mr. Hayfield's review.

Mrs. Stanton had discussion regarding the increase in the number of vacant properties in the City. She noted that in 2018, there were 557 vacant properties and that according to the 2019 list, that amount increased to 776. There was further discussion regarding the matter.

Mrs. Stanton made a motion that Council be provided with an updated vacant property list prior to the next meeting, to include whether or not the vacant property fee has been paid and using the address on the tax bill. The motion was seconded by Mrs. Mock.

It was noted the matter had been previously assigned to Mr. Rosenthal but will need to be reassigned.

Reverend King commented that last year a lot of the letters sent out were returned, and that out of that two people did pay the vacant property fee.

Mrs. Stanton reminded Council members that posting on public property was a violation of a City ordinance. She questioned whether or not any such postings have been removed and whether any fines were issued. There was further discussion regarding the matter.

MAYOR

Mayor Frank Janakovic reported his attendance at the recent Peace Walk and Roxbury Civic Group Event.

Mr. Janakovic noted he and Mr. Hayfield had the opportunity to meet with 15 ambassadors and political party members from the Netherlands for discussion of government, trade opportunities and Johnstown. The group later had the opportunity to meet with Pittsburgh's Mayor Peduto.

Mr. Janakovic congratulated Rosemary Pawlowski on the opening of the Gallery on Gazebo.

The Mayor stated that he volunteered at one of the presentations at the State Theater. He noted that preliminary work has been completed by Discover Downtown in the hopes of selling the theater.

Mr. Janakovic met with the Community Foundation recently for discussion of grant monies for some of the City's projects, including demolition of buildings in the West End.

The Mayor had a meeting with Robert Forcey, the new publisher of the Tribune Democrat.

He noted activities within the JARI Growth Fund.

Mayor Janakovic stated he is a member of the Vision 2025 Committee, Discover Downtown Committee and Regional Partnership Group, all working very hard to move Johnstown "up the scale".

The Mayor commended the Codes Department and members of Public Works for conducting a cleanup in Moxham, Prospect, Coopersdale, and part of the Kernville area on May 1 and 2. He stated the cleanup resulted in 8.5 tons of garbage and rubbish, 114 tires and 52 televisions.

Mayor Janakovic congratulated the Johnstown Tomahawks on winning the league championship. The team will be playing for the Robertson Cup starting Friday, May 10, 2019.

CITY SOLICITOR

Solicitor Elizabeth Benjamin noted that an Executive Session with regard to personnel was held prior to the commencement of tonight's meeting.

The letter regarding the retirement of Officer Shawn Rager's badge was available for all Council members to sign.

Ms. Benjamin noted she did contact Counsel for Crown American and was awaiting a response.

She asked the City Manager for further information regarding the flood channel.

Ms. Benjamin will provide Council with an update with regard to the Prospect Venture properties and the Valley Pike sidewalk at the next meeting.

Reverend King noted her attendance at the community event recently held at Roxbury Park. She thanked the County, Codes, Public Works and Tom Oldham and his group for all the help they provided during the recent cleanups held in Moxham and Prospect.

Mayor Janakovic thanked the Johnstown School District and Nutrition, Inc. for the spaghetti dinner.

Mr. Vitovich reported the Public Works continues patching potholes and running the street sweeper daily. Grass mowing has commenced.

Improvements continue to the Sargent's Stadium at the Point.

He noted the vac truck has been utilized for storm and sanitary sewer lines. He noted to call 533-2089 to schedule a pickup of yard waste. He thanked Jarrod and his staff for all their efforts.

Mr. Vitovich noted a mechanic was needed at the City Garage.

Mrs. Stanton reported her attendance at the recent Annual Covered Dish Dinner for the Moxham Community Walk Group. Walk times have now been changed to Wednesday evening at 6:00 p.m.

Mayor Janakovic inquired if monies are available to subcontract grass cutting jobs to support Public Works. Mr. Hayfield commented there was not a specific fund for that but monies could be found to help with some of the approximately 200 vacant lots. There was discussion regarding the liability issue.

PUBLIC COMMENT-NON-AGENDA ITEMS

Homer Mattes, 1160 Milford Street, Johnstown, addressed Council with regard to speed bumps on Plainfield Avenue and Derby Street that he would like to see either ground down or removed. Mr. Mattes was also concerned about The Haven, a local restaurant/bar/pub, constantly blocking the alleys near his home. He stated that police do not respond when he calls them and further

stated that he was threatened by employees of the business. Mr. Mattes requested that No Parking signs be placed in the alleys.

Mayor Janakovic asked the City Manager, Public Works and the Police Department to look into the matter.

Mr. Mattes was concerned that the noise ordinance which has been in effect for some time has not been enforced.

Mrs. Stanton commented that she has reported complaints about the speed bumps for years and the condition still remains. Mayor Janakovic noted that in conversations with EADS and the City Manager was when the other projects were completed, any money left would be used to restore that area.

Mrs. Stanton commented that Mr. Barber had not signed up to speak at tonight's meeting, that a person at a previous meeting who was not signed up on the agenda was not permitted to speak. There was further discussion regarding the matter.
