JOHNSTOWN CITY COUNCIL SPECIAL MEETING MINUTES Tuesday, July 23, 2019

City Council met in a stated session for the general transaction of business.

Mayor Frank Janakovic called the meeting to order at 5:00 p.m.

Reverend Sylvia King offered the invocation. The Pledge of Allegiance was recited.

The following members of Council were present for roll call:

Mayor Janakovic, Reverend King, Mrs. Mock, Mr. Vitovich, Mr. Williams (5). Absent: Mrs. Stanton, Mr. Britt (2).

George Hayfield, City Manager, and Elizabeth Benjamin, Solicitor, were also present.

PUBLIC COMMENT - AGENDA ITEMS ONLY

John DeBartola, 1197 Bedford Street, presented before Council with regard to Resolution No. 1 regarding the Berkley Hills Golf Course and Resolution No. 2 regarding a fixed rate, tax-exempt loan.

He inquired as to how Mr. Hayfield could solicit bids for the sale of the golf course with an existing five-year lease. He inquired as to how Council could authorize a loan in the amount of \$6,800,000 and put the City in debt for 13 years. Mr. DeBartola urged Council to reconsider the resolutions.

Mrs. Mock noted the resolution refers to a refinance of existing debt at a lower interest rate for a shorter duration and lower payments. Mayor Janakovic indicated the resolution shortens the duration by four years at a savings of over \$300,000. Mr. Williams commented the loan balance was \$6,375,000 and that \$400,000 would be applied to other accounts or other things.

- Mrs. Mock made a motion to approve the ordinance. The motion was seconded by Mr. Vitovich.
- Mr. Williams commented that per the codified ordinance, the provision for penalty would be in conflict with stating that ProDisposal would be in charge of

collections and has to be removed as criminal citations cannot be filed. He also noted in the contract with Pro Disposal, there is a two can, six bag limitation, and that the codified ordinance states three cans and six bags. Mr. Williams inquired if members were aware that when it passed the resolution to direct the City Manager to enter into that contract, that it obligated the City to \$15,175,860 for the terms. He stated, in ProDisposal's attachment pages, the base collection rate is \$18.97 starting September 1, 2019, and that when extending that out, the total annual cost is \$1.3. Calculating that out into three bills a year totals \$75.88, or a \$61 increase per year. Mr. Williams stated the current ordinance caps it at \$166 a year. He commented further that the contract with ProDisposal puts the City "on the hook" for any difference not collected.

Ms. Benjamin explained the unit given out with the request for proposals were identified as being estimated for calculation purposes. She stated there is various language indicating that there are unanticipated fluctuations, there is that concern, and that was something that could be clarified via an amendment to the agreement. She further stated the title does contemplate that the enforcement section would be eliminated, that Council can make a motion to amend the ordinance to eliminate the penalty section and adopt the proposal as amended.

Mrs. Mock mentioned that ProDisposal came in as the lowest bid. There was further discussion regarding the contract. Ms. Benjamin offered an additional explanation of the contract with ProDisposal.

Mrs. Mock made a motion to amend and adopt Bill No. 23 to include the elimination of Section 1060.21, regarding Enforcement, and 1060.99, regarding Penalty. The motion was seconded by Mr. Vitovich and passed by the following vote:
