JOHNSTOWN CITY COUNCIL SPECIAL MEETING MINUTES WEDNESDAY, AUGUST 26, 2020

City Council met virtually in a stated session for the general transaction of business. Mayor Janakovic called the meeting to order at 12:00 p.m.

Reverend King offered the invocation. The Pledge of Allegiance was recited.

John Trant, Interim City Manager; Elizabeth Benjamin, Esquire, City Solicitor, were also present.

PUBLIC COMMENT

Sam Genovese, 204 Bellview Street, Johnstown, asked to address concerns and offer his opinion regarding the sewage sale. Ms. Benjamin explained, since this was a special meeting of Council, agenda items were limited to that which was advertised. As it was a public comment period and the parameters were such, discussion should be related to the pending matters currently before Council, which related to the retention of legal counsel for purposes of allowing the City to realize the proceeds of the sale.

Mayor Janakovic asked Mr. Genovese to defer his comments until the next Council meeting on September 9, 2020. Mr. Genovese stated there had been no opportunity to meet with Council for discussion. Considerable erroneous information was given regarding the sewer testing. Mayor Janakovic reiterated that Mr. Genovese would be given time to speak on September 9, 2020 meeting to address all his concerns.

Mr. Genovese stated, for the record, that with all due respect he felt that he was being denied the opportunity to express his constructive position as far as it related to the sewer system. He asked Council to advertise in the newspaper that a public meeting would be held to discuss the sewer system where all residents could attend. Mayor Janakovic noted the entire public had the opportunity to speak at Greater Johnstown High School last month. Mr. Genovest asked Council to consider one more public meeting regarding the matter.
