JOHNSTOWN CITY COUNCIL SPECIAL MEETING MINUTES Wednesday, August 28, 2019

City Council met in a stated session for the general transaction of business. Mayor Frank Janakovic called the meeting to order at 5:00 p.m.

Mr. Britt offered the invocation. The Pledge of Allegiance was recited.

The following members of Council were present for roll call:

Mr. Britt, Mayor Janakovic, Mrs. Mock, Mrs. Stanton, Mr. Vitovich, Mr. Williams (6).

Reverend King entered the meeting at 5:03 p.m.

George Hayfield, City Manager, and Elizabeth Benjamin, Esquire, City Solicitor, were also present.

PUBLIC COMMENT-AGENDA ITEMS ONLY

John DeBartola, 1197 Bedford Street, came before Council for discussion of Resolution 1 on the agenda regarding the demolition of 18 properties. He expressed a concern that this would become a larger problem down the road.

With regard to Resolution 2, the joint motion and stipulation of settlement with regard to contempt sanctions filed by Mrs. Stanton and Mr. Williams, Mr. DeBartola requested an explanation of the settlement as to whether it involved the executive session lawsuit or the budget lawsuit or what it involved.

Mrs. Stanton explained there was a total of approximately 880 vacant properties and proposed taking legal action against the vacant property owners who had not paid the fee, but that the majority of Council voted to table the matter. She stated Council in 2015 repealing the property registration for properties being purchased was a "huge mistake", that rental properties are no longer registered, and that the City is in violation of its own ordinances by not enforcing the rental property inspections.

Ms. Benjamin explained Resolution 2 references a Civil Action 2017-4061, Petition for Contempt Sanctions filed with regard to allegations regarding the budget for 2018-2019. She stated it was a proposed action to resolve the matter by way of an agreement between the parties that would be filed with the court if approved by Council. Mrs. Stanton would be permitted to comment further when the resolution was read.

- Mrs. Stanton stated, when she inquired as to the owners of the properties, she was surprised to learn that the tax map parcel numbers do not match the properties, that Council must be certain the addresses of the properties match up with the tax map parcel number.
- Mrs. Stanton made a motion to table until the correct information is provided to Council. The motion was seconded by Mr. Williams and passed by the following vote:

Mrs. Stanton requested that the City Manager and Department of Community

- Mr. Williams commented the matter involves a motion for contempt.
- Ms. Benjamin further stated this was an agreement mutually between the parties to resolve the lawsuit and to authorize the financial payment as it pertains to costs in the amount of approximately \$173 for filing and copying costs.

The motion passed by the following vote:

Yeas: Mrs. Mock, Mr. Vitovich, Mr. Britt, Mayor Janakovic (4).

Nays: Reverend King (1).

Abstentions: Mrs. Stanton and Mr. Williams abstained from voting on the motion

as they are the Petitioners.
