A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JOHNSTOWN, AUTHORIZING AND DIRECTING THE CITY MANAGER TO SUBMIT A LETTER OF INTENT REQUESTING THE US ARMY CORPS OF ENGINEERS UNDER PROVISIONS OF SECTION 1135 OF THE WATER RESOURCES DEVELOPMENT ACT OF 1986 UNDERTAKE A STUDY TO DETERMINE THE FEASIBILITY OF ONE OR MORE ENVIRONMENTAL RESTORATION PROJECTS ALONG THE STONYCREEK, LITTLE CONEMAUGH AND CONEMAUGH RIVER WATERSHEDS WITHIN THE CITY OF JOHNSTOWN.

WHEREAS, the City of Johnstown has identified a great interest in the revitalization of the ecological, economical and recreational opportunities afforded by the river system; and

WHEREAS, through collaboration between the city and Army Corp of Engineers potential funding sources have been identified to study the aforementioned opportunities; and

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JOHNSTOWN, AUTHORIZING AND DIRECTING THE CITY MANAGER AND DIRECTOR OF FINANCE TO SEEK PROPOSALS FOR THE BORROWING OF A 2016 TAX ANTICIPATION NOTE/LINE OF CREDIT IN AN AMOUNT NOT TO EXCEED \$3,500,000 AND FOR CLOSING NOT LATER THAN December 18, 2015.

WHEREAS, the City of Johnstown ("Local Government Unit") expects to receive current revenues, as yet uncollected, during the first two quarters of fiscal year ending December 31, 2016; and

WHEREAS, the Local Government Unit will have inadequate funds for operating expenditures during the first two quarters of 2016, based on funds flow analysis of tax receipts; and

WHEREAS, the Local Government Unit has determined that it is necessary to borrow for the purpose of meeting expenses during the first two quarters of 2016 by issuing a note, to be repaid from anticipated revenues.

NOW, THEREFORE, BE IT RESOLVED, by the City Council (hereafter the "Governing Body") of the Local Government Unit, directs and authorizes the City Manager and Director of Finance to seek proposals and/or written quotes for the borrowing of funds through a Tax Anticipation Note not to exceed \$3,500,000 and for closing no later than December 18, 2015, and subject to the final adoption of the 2016 City of Johnstown operating budget by City Council.
