AWARDED CONTRACT 2016-12 FOR THE CONSTRUCTION OF THE CENTRAL PARK ELECTRICAL UPGRADES PROJECT IN THE CITY OF JOHNSTOWN.

WHEREAS, Church & Murdock Electric, Inc. is the apparent low bidder for Contract 2016-12, with a Total Base Bid and three deduct Alternate Bid Amounts to be Awarded of \$52,900.00.

RESOLUTION NO. 9844

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JOHNSTOWN, PENNSYLVANIA AUTHORIZING THE INTERIM CITY MANAGER TO SIGN ALL DOCUMENTS NECESSARY TO APPLY FOR FUNDING ASSISTANCE FROM THE PENNSYLVANIA INFRASTRUCTURE INVESTMENT AUTHORITY IN THE AMOUNT OF \$10,900,000.00 TO BE USED TOWARDS IMPROVEMENTS TO THE INNER CITY SEWER SYSTEM IN THE 8TH WARD AREA OF THE CITY OF JOHNSTOWN.

WHEREAS, the City Council of the City of Johnstown has entered into a Consent Order and Agreement with the Pennsylvania Department of Environmental Protection; and

WHEREAS, major repairs and rehabilitation are necessary to comply with the mandates of the Consent Order and Agreement; and

WHEREAS, the State of Pennsylvania offers low interest loans and grants for successful applicants to complete sewer and water related projects; and

WHEREAS, it is the desire of the City Council to access as many funding opportunities as possible to complete all repairs necessary involving the Inner City Sanitary Sewer System.

NOW THEREFORE, BE IT RESOLVED, that the City of Johnstown (the Governing Body) shall be, and the same hereby are authorized to submit a Financial Assistance application to the Pennsylvania Infrastructure Investment Authority (PENNVEST), substantially in the form presented at this meeting for the purpose of financing/partially financing the construction, rehabilitation and/or extension of the sewer system. Appropriate officers of the Governing Body are hereby authorized to execute all certifications and documentation required in connection with the application.


