WHEREAS, HRI, Inc. is the apparent low bidder for Contract 2016-08, Hornerstown & Industrial Park Interceptor Rehabilitation & Stormwater Separation Project, with a Total Base Bid with Slag Alternate and Additive Alternate #1 with Slag Alternate, for a total of \$4,577,192.00.
