A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JOHNSTOWN, AUTHORIZING AND DIRECTING THE DIRECTOR OF FINANCE AND/OR INTERIM CITY MANAGER TO TAKE ALL ACTIONS NECESSARY TO SEEK AND OBTAIN PROPOSALS FOR THE BORROWING OF A 2017 TAX ANTICIPATION NOTE/LINE OF CREDIT IN AN AMOUNT NOT TO EXCEED \$1,500,000 AND FOR CLOSING NO LATER THAN DECEMBER 31, 2016.

WHEREAS, the City of Johnstown ("Local Government Unit") expects to receive current revenues, as yet uncollected, during the first two quarters of fiscal year ending December 31, 2017; and

WHEREAS, the Local Government Unit will have inadequate funds for operating expenditures during the first two quarters of 2017, based on funds flow analysis of tax receipts; and

WHEREAS, the Local Government Unit has determined that it is necessary to borrow for the purpose of meeting expenses during the first two quarters of 2017 by issuing a note, to be repaid from anticipated revenues.

NOW, THEREFORE, BE IT RESOLVED, by the City Council (hereafter the "Governing Body") of the Local Government Unit, directs and authorizes the Director of Finance and/or Interim City Manager to seek proposals and/or written quotes for the borrowing of funds through a Tax Anticipation Note not to exceed \$1,500,000 and for closing no later than December 31, 2016, subject to the final adoption of the 2017 City of Johnstown operating budget by City Council.
