WHEREAS the Pennsylvania Department of Community and Economic Development makes available loans and grants-in-aid to such projects through the Municipalities Financial Recovery program for projects that implement adopted recovery plan strategies.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Johnstown is hereby authorized to make application for such a loan or grant under authority of the Municipalities Financial Recovery Act.

BE IT FURTHER RESOLVED that the proper officers of the City of Johnstown are hereby authorized on behalf of the City to execute applications, agreements, contracts or other documents necessary to apply for and to secure aid for the City of Johnstown from the Department of Community and Economic Development under and by authority of the Municipalities Financial Recovery Act.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JOHNSTOWN, PENNSYLVANIA AUTHORIZES A POLICY CHANGE FOR CITY PENSION SYSTEM INVESTMENTS INCLUDING POLICE, FIRE, SEWER AND NON-UNIFORM EMPLOYEES

WHEREAS, the City of Johnstown has four(4) pension systems that have diversified investments to protect employee's projected retirements and present funding of retirees; and

WHEREAS, the pension systems are underfunded for the long-term and numerous steps must be initiated to insure the payment of benefits for all retirees; and

WHEREAS, on February 24, 2017 a joint committee of the Police, Fire, Non-Uniform and Sewer Employees met with investment advisers to review future investment strategies and enhance and protect retirees futures; and

WHEREAS, the joint committee by a majority vote wished to change the policy on the distribution of the investments; and

NOW THEREFORE, BE IT RESOLVED that the City Council of the City of Johnstown, Cambria County, in the Commonwealth of Pennsylvania hereby authorizes the following policy for the diversification of funds and investments for the Police, Fire, Sewer and Non-Uniform pension funds;

- Increase the Plan's total equity target from 60% to 65%. The domestic equity target would be increased to 52.5% and the international equity target would remain at 12.5%
- Eliminate the 2% investment manager target to cash. Benefit payments and expenses are currently maintained through a variety of cash disbursement accounts at custodian AmeriServ. Investment managers should maintain portfolios that are fully market invested.
- Reduce the current target to intermediate fixed income from 38% to 30%.
- Add a 5% allocation to a Global Tactical Asset Allocation ("GTAA") mutual fund strategy. This
  new strategy will be designed to add yield to the overall portfolio through diversification to
  nontraditional and underrepresented securities and strategies. This new strategy is intended
  to add additional yield above the current low yield fixed income environment.
