JOHNSTOWN CITY COUNCIL MINUTES Wednesday, October 26, 2016

- City Council met in a stated session for the general transaction of business. Mayor Frank Janakovic called the meeting to order at 6:00 p.m. City Manager Melissa Komar offered the invocation, and the Pledge of Allegiance was recited.
- Mayor Janakovic, on behalf of Council, Administration, employees and citizens, expressed sincere condolences and sympathies to the Shawn Rager Family.
- Mrs. Rager thanked the citizens of Johnstown, Richland and the surrounding communities and Craig Foust and Kristen Denne for the support provided to her and her four sons.
- Mayor Janakovic noted an Executive Session was held with regard to litigation and personnel issues prior to the start of the meeting

The following members of Council were present for roll call:

Interim City Manager Melissa Komar and Elizabeth Benjamin, Solicitor, were also present.

COURTESY OF THE FLOOR ON AGENDA ITEMS ONLY

- John DeBartola, 1197 Bedford Street, Johnstown, addressed Council with regard to Bill No. 40 of 2016, which he read into the record as follows: An ordinance by Council of the City of Johnstown, Cambria County, Pennsylvania, placing on the May 17, 2017 primary election ballot for the City of Johnstown the voter referendum question for consideration by the City of Johnstown electorate to reduce the number of elected Councilpersons from six Councilpersons and one Mayor to four Councilpersons and one Mayor effective January 1st, 2018.
- Mr. DeBartola noted that keeping the number of members at seven is making sure we have individuals that "really want to represent the community" and "want to

build Johnstown into a better place". He requested Council to table the bill and "keep the Council at seven".

REPORT BY CITY MANAGER

- Melissa Komar, Interim City Manager, reported on two fires, one at 900 Oak Street and the 1100 block of Virginia Avenue. She commended the City firemen for preventing the fire from traveling to the adjacent structures.
- Mrs. Komar noted the City emergency management, fire and police implemented the recent Trump Rally at the Cambria County War Memorial.
- Assistant Chief Statler, Captain Shrock, Firefighters Carnahan and Moore recently completed the FEMA structural collapse technician school at Virginia Beach. She noted the PEMA Region 13 Grant paid for the program.
- She reported that eight City police officers were given letters of commendation for the barricaded person with a gun on October 5th, 2016, in the West End.
- Currently SMG and Cambria County War Memorial are working on improving the scheduling efficiency throughout the department and have participated in the state funded aggressive driving program.
- Mrs. Komar noted new parking arrangements at the Lincoln Street Parking Garage working with Duke LifePoint to fill the parking garages. The ITC Parking Garage was also sold out during the Trump Rally. She stated Finance will be exploring new insurance means to reduce future expenditures.
- The Interim City Manager reported that Public Works has cleared the trees off the hillside along Millcreek Road. She noted the leaf vac and street cleaner are working throughout the nights and early mornings to keep the streets cleaned. Public Works has participated in a class for traffic control signage and devices.
- Mrs. Komar noted that demolition for fire structures are being addressed, and the City will lien the properties for the demolition costs. Ms. Daly visited Philadelphia to meet with the U.S. Economic Development Administration, which granted \$1.9 million for the project. She noted the meeting was to inform EDA of the recent closing of the Cambria Rowe Business College and its impact on the community. EDA was also updated on a new tenant and asked for approval of funding for the Conrad Building.

- Ms. Daley noted a \$1.9 million grant to JBDBC and that there would be an educational piece in that building that would focus on either education to older adult students and/or ITE, information technology. Final approval should be within the next few days.
- Mrs. Komar noted the Housing Authority will provide information to the public regarding the recycling program and the location of recycling centers.
- Mr. Vitovich noted the Housing Authority has agreed to help with the recycling program. Mr. Williams noted that money was received years ago to cover the cost of the recycling receptacles.

REPORT BY THE MAYOR

- Frank Janakovic, Mayor, thanked Forever Broadcasting for organizing the Halloween Parade as well as all of the sponsors, organizations, school bands, fire departments, police departments, businesses, individual participants, and the crowd in attendance, as well as the police and fire departments.
- The Mayor noted Mr. Polacek will speak later on with regard to the Visioning Committee meeting.
- He noted that Discover Downtown is moving forward with plans for the Christmas Parade and Christmas tree in Central Park. A gift shop will operate during the holiday season and a life-size train to pull passengers around the central business district for one weekend in December. Vendors will be in the park selling food, drinks and gifts. He stated local businesses will be urged to stay open later than usual during the holiday season. Toy Soldiers were painted and placed around town. Full details will become available in the future with regard to a project by Discover Downtown.
- Mayor Janakovic noted damage to the scarecrows in Central Park, which prompted Discover Downtown to install cameras. He thank the Discover Downtown group for their efforts.
- Congressman Rothfus and Wessel and Company conducted a roundtable discussion with regard to the overtime law effective December 1st, 2016. Businesses will be required to pay overtime for employees making less than \$47,000.
- Cambria County Transit Authority, County Redevelopment Authority, Community Foundation, Discover Downtown, the Visitor's Bureau, Visioning 2025, JAHA and other individuals attended a recent Lift Johnstown quarterly

- meeting. There was discussion regarding the beautification of the Old Conemaugh section of the City as an entrance into the City.
- Mayor Janakovic stated that funding is in place to complete the renovations on the Incline Plane.
- Lift Johnstown will connect local trails for Johnstown to become a destination point for tourists.
- The Mayor congratulated Bob Layo on his retirement as President of the Chamber of Commerce.
- Cable Channel 14 continues to broadcast the sewer project schedule. He reminded residents that up to \$1,000 is available for those who have completed their sewage work and pressure testing.

There was discussion regarding the sewage camera televising.

REPORT BY THE CITY SOLICITOR

- Elizabeth Benjamin, Esquire, City Solicitor, discussed Bill No. 29, which was tabled at the last meeting, and reviewed potential amendments to Section 206. She distributed a proposed motion to amend to be addressed at the appropriate time by Council.
- Mr. Williams referred to a September 20, 2016 document with regard to the execution of contracts and agreements.
- Attorney Benjamin discussed the ability of City Council to enter into agreements and contracts with the number of Council seats coming up for appointment or the contest in the following election. She noted that Council can make a motion authorizing her to offer a legal opinion on the matter and its influence on the contracts for future consideration by the City.
- Mr. Williams made a motion to request that an opinion be rendered. The motion was seconded by Mrs. Stanton.
- Mayor Janakovic questioned the generality of the motion as opposed to a specific ordinance or resolution. There was further discussion regarding the matter.

Mrs. Mock noted a Coffee with Cops with the West End Improvement Group was recently held.

OLD BUSINESS

Mr. Williams presented a referendum under the Home Rule Charter to attempt to place on the ballot for the citizens to decide whether meetings should be earlier than 5:00 p.m. He will also submit another referendum on Monday for the same consideration under the Home Rule Charter for the possible reduction of the size of Council, which had already been tabled.

Attorney Benjamin explained that the referendum can remain tabled, which does not prevent the actions of Mr. Williams to form a petitioners' committee. She stated the referendum will remain on the table, but if taken off table at the next meeting, the referendum might impact the petitioners' committee procedures. She is not aware of anything that prohibits the petition procedures from taking place because an ordinance has been tabled.

There was discussion with regard to meetings held before 5:00 p.m. and also the size of Council.

Attorney Benjamin clarified that the Home Rule Charter states the voters may by initiative propose such an ordinance for enactment or appeal if a proposed ordinance is not adopted. Mr. Williams noted the ordinance was not adopted nor defeated. He stated the City Manager has 30 days to certify the signature and 60 days for Council to act. Attorney Benjamin explained further that nothing can go to referendum until there has been an ordinance presented. Once an ordinance is presented, any failure to act is also interpreted as a failure to act.

PUBLIC COMMENTS ON NONAGENDA ITEMS

Bill Polacek, CEO, JWF Industries, provided an update as Chair of Vision 2025 as well as JARI. He stated Vision 2025 creates a collaboration amongst the community. Mr. Polacek indicated that Senator Toomey, Senator Casey, Congressman Rothfus, state representatives, and the Governor have been briefed on the 2025 plan. A representative from Harvard provided opinions on the beautification of the area and the river walls. Mr. Polacek noted that the 800 people signed up see the opportunity and potential in this region. He stated, "Lowering the cost of flood insurance is critical to future development." Cleaning the rivers and river walls recreation as opposed to just flood control is being considered. Mr. Polacek indicated that November marks the end of the first year of people giving their time, energy, and money to make a difference in this town. He invited Council members to attend the First Annual Vision 2025 Celebration.

Mr. Polacek noted federal and state monies will be available and further noted the Governor has made a commitment to our community.

Mayor Janakovic explained that money coming into the City is not "magically appearing" because we are all nice guys or ladies, but rather there has been a lot of work behind the scenes.
