JOHNSTOWN CITY COUNCIL MINUTES Wednesday, December 10, 2014

City Council met in a stated session for the general transaction of business. Mayor Frank Janakovic called the meeting to order at 6:04 p.m. Acting City Manager, Carlos Gunby, offered the invocation, and the Pledge of Allegiance was recited.

The following members of Council were present for roll call:

City Solicitor David Andrews, and City Engineer, Steve Sewalk were also present.

APPROVAL OF MINUTES

- Mr. Mickel made a motion to approve the minutes of the November 12, 2014 meeting. The motion was seconded by Mr. Johncola and ruled on by the following vote:

COURTESY OF THE FLOOR

- Donna Barber of 824 Sherman Street, Johnstown, came before Council to discuss her concerns with codes and harassment by the City. She presented her concerns at Council's last meeting, and Council had requested that she write a letter to Council.
- Mayor Janakovic said that Council will address her letter through codes after everyone speaks. As to the harassment, he suggested that she speak with the Acting City Manager personally.
- Charlene Stanton of 184 Sell Street, Johnstown, expressed three concerns regarding city government. Her first concern was on code enforcement. She noted Prospect properties that remain in violation of the City code ordinances. She made the original complaints on the properties in May and a magistrate hearing was held in August. The Defendant pleaded guilty and requested an

additional 45 days to bring the properties into compliance. She said the properties are still in violation three and a half months later. She asked what the next step was in holding the owner's responsible and what follow-up has been done on the offenses. She requested that a codes officer visit Prospect and prepare an accurate write-up on all units in violation. She also stated that the Cambria County Redevelopment Authority owns City properties that are in violation of the code ordinances. She does not understand why magistrate charges are not being pursued. She asked how Council can expect residents to be held accountable for their properties when others get a free pass.

Ms. Stanton then addressed garbage problems. She said there is illegal dumping taking place throughout the City. She suggested placing a notice on the City website or in the paper concerning the Cambria County Solid Waste Authority located in Ebensburg, which will take many items, such as TVs, microwaves, et cetera, free of charge. She said educating the public about the Authority may cut down on illegal dumping. She cited that under PA State law you must recycle. The City receives added revenue through recycling and grant money from the state.

Ms. Stanton's third concern was in regard to sewage. She noted the distribution of letters informing residents of the new requirements, but has not seen one. Some realtors are still telling clients that pressure tests must be conducted before selling their homes. The Department of Environmental Protection (DEP) says that is not correct. Many people are confused as to Council's mandate. She is also concerned as to why employees of EADS and the City engineers are going door to door in the West End asking for permission to enter homes to check lateral lines. She heard they were not showing any identification. She personally believes no one should let anyone into their homes without proper identification.

Lonnie Rietscha of 121 Davis Street, Coopersdale, wanted to discuss the former tennis courts in Coopersdale with Council. He stated the type of zoning change has the potential to set a precedent if granted for any residential property in the City. Not one Coopersdale resident has voiced being in favor on an official record for the zoning change. He also said the Planning Commission nor any other entity has been in favor of the request. He noted a family with a child that has a health condition would be aggravated if the change is permitted. He said the zoning change should have been sought prior to putting up a building and running the business. - Attorney Leonard P. Vigna of 360 Stonycreek Street, Johnstown, has been asked to speak on behalf of many residents that are in opposition of the proposed zoning/classification change from R-1 to C-1 to the property at 138 Cooper Avenue. He also understood the proposal would also alter or change the definition of C-1 throughout the City. He reiterated the Planning Commission has already rejected the proposal and the public hearing was held on November 6, 2014. Many Council members were not in attendance. Summary packets of the proceedings will be presented. He strongly encouraged Council to review the information before voting. A petition was presented at the hearing for review of 72 residents that were not able to make the public hearing, all in opposition, all residents of the City. He concurred with Mr. Rietscha's concerns. The concerns are safety issues, noise issues and living conditions issues. He added that Coopersdale has historically been a residential neighborhood. The proposed business for the property is a landscaping business with heavy machinery that will create noise and dust. He and the residents do not believe the business is right for that particular location, and the change would have ramifications throughout the City in the future.
- Joseph Warhul of 44 Clover Street, Johnstown, discussed his views on boards, commissions and authorities. He reported on the system of government with a city manager, a council, a mayor, many boards and authorities. He stated the system is flawed. He said that when local officers blame appointees for problems it leaves voters unable to hold elected individuals accountable for their decisions. He does not feel Council holds people accountable for their decisions. He noted a Shade Tree Commission appointed by the city government. He said the Commission has a Facebook page that does not allow all residents to comment freely. He informed the Solicitor that the Commission Chairman is on the government page soliciting donations in addition to restricting free speech to residents. He also does not understand why the government organization holds meetings at the Chairman's private residence. He noted that the Shade Tree Association and the Shade Tree Commission seemed more inclined than a government organization and a nonprofit organization should be. Rather than place blame or point fingers, he suggested that Council employ Article 3 Section C of the Home Rule Charter, which allows an entire board to be abolished. If not, Article 3 Section B can remove a member of a board, commission or committee.
- Mr. Warhul had a list of Council's appointments coming up and pointed out that Council is lacking in people of color. He asked that minority candidates be given some consideration in fairness to the City of Johnstown.

REPORT BY THE CITY MANAGER

Acting City Manager, Carlos Gunby, noted the unfortunate five alarm fire earlier in the morning on Dorothy Avenue in the West End section of Johnstown. He urged all to keep those affected by the fire in their thoughts and prayers. The Red Cross is accepting donations on behalf of the fire victims.

Mr. Gunby met with Rosalie Danchanko, the Executive Director of the Johnstown Free Medical Clinic, the City, along with other emergency services around the City, and a shared services plan has been coordinated for City residents and within the region that will help in times of disaster and large events. He thanked the Johnstown Free Medical Clinic and the other emergency services representatives for coming together and putting together a new and improved plan for the City. Additionally, he congratulated the Johnstown Free Medical Clinic on their receipt of a \$225,000 grant that will help support continued efforts of the clinic to provide healthcare to all patients.

Mr. Gunby also stated that the City is in the process of finalizing offers for capital purchases. Costs came in at estimate. There are some applications and other items that still need to be completed.

The John B. Gunter Community Leadership Class of 2014-2015 has selected Roxbury Park as the proposed location for the 2015 revitalization project. Mr. Gunby fully supports the project and said the program does phenomenal work throughout the communities. The program raises the funds and does the work themselves.

Mr. Gunby attended the Prospect viaduct public meeting. He reiterated that the viaduct will remain a single lane operation throughout the project. There will be controlled traffic signals on both ends of the viaduct. There will be delays, but there will be daily access as well as a shuttle service from the bottom end to the top of the viaduct.

Mr. Gunby next mentioned that the Mayor and he had a positive meeting with the leadership of Conemaugh Hospital. The meeting had great discussion that opened doors for future collaboration and opportunities.

Mr. Gunby congratulated the Moxham and West End organizations for their light up nights. He recommended driving around the City to look at all of the lights.

REPORT BY MAYOR

- Mayor Janakovic had the opportunity to attend the Veteran's Day Parade and to meet with Governor-Elect Wolf to discuss the needs in Johnstown. He hopes Johnstown will have a good connection from Johnstown to Harrisburg with the newly elected governor. He also had the opportunity to attend the Economic Summit where he had the chance to explore the operation of the businesses in the area. He attended the Chamber of Commerce meetings, the Discover Downtown and Regional Partnership meetings as well.
- Mayor Janakovic then discussed a meeting on the City waterways. He noted the debris in particular areas of the City, acid water drainage, repair to walls, inlets, streams, et cetera. The Army Corps of Engineers will be visiting Johnstown to discuss the issues.
- Mayor Janakovic echoed Mr. Gunby's comments on Conemaugh Hospital. He said it was a positive meeting on planning collaboration and fiscal matters to promote joint projects in the future. The hospital has offered Council a monthly or bi-monthly meeting as needed to look at the progress.
- Mayor Janakovic attended a community leader's breakfast at the Johnstown Administrative offices. He commended the work of Immaculate Conception Church on Broad Street that are keeping the history alive. He also attended the Moxham playground tree lighting. He commended the efforts to make the playground a success.
- Mayor Janakovic summarized a roundtable discussion with the Regional Partnership, the business community, the foundations, legislators, et cetera, looking at where the City is heading and what is taking place throughout the City. The City received a grant for \$1.9 million on the Conrad building. The train station received \$848,000 for a multi-modal and PennDOT grant. He noted that 24,000 people come in and out of the city through the train station each year. The parking garage received \$600,000 from the CFA and another \$555,000 through the multi-modal grant and PennDOT. The Iron Street project received \$1.2 million, \$850,000 and \$350,000 through the JRA program. A cop grant was received for two officers.

REPORT BY THE CITY SOLICITOR

City Solicitor, David Andrews, reported that labor negotiations for fire fighters take place on Tuesday, December 16, 2014. He will report back to Council following that session.

REPORT BY THE CITY ENGINEER

- City Engineer, Steve Sewalk, passed out a hard copy of his report to Council. He highlighted some of the major projects. Construction is still proceeding in the Oakhurst area. Throughout the different areas, approximately 500 letters have been mailed out thus far referencing different issues such as downspout removals and lateral connections. He anticipates roughly an additional 500 letters to be sent to people in different areas, particularly the Woodvale/Prospect area. Construction will start in that area within the next month.
- Regarding Ms. Stanton's earlier comments regarding employees not having identification, he said the employees do have I.D.'s. He will address the issue with the employees. He apologized to anyone offended.

The Moxham section Phase 1 PENNVEST should be awarded in January.

- Mr. Sewalk then answered questions from Council as to the schedule of construction.
- Mr. Gunby reported that there would be a special meeting on Wednesday, December 17, 2014, to discuss these issues. He said Council needs to discuss the sewer projects. Nothing has changed significantly to this point, but there are difficulties coming with paving roads. Paving is not included in PENNVEST. Council would need to come up with an additional \$3 million a year to continue paving roads throughout the City. Council is already paying PENNVEST debt. He then answered questions from Council.

REPORT OF ECONOMIC DEVELOPMENT DIRECTOR

- Renee Daly, Economic Development Director, has been in discussions with Ms. Danchanko for her to present to City Council next month. She wished to explain the mission of the Johnstown Free Medical Clinic.
- Ms. Daly also reported that there is one loan under review and the residential development has been incredibly busy. There were 73 code complaints in the

month of November. Of those, 24 were compliant after the notification within their proper timeframe, 13 have been notified and have not been compliant. Those 13 are owned by the County Redevelopment Authority. There is a meeting with the Authority on December 15, 2014 to discuss with their attorney what they need to do to be held accountable.

- Mr. Gunby stated that the State of Pennsylvania is not required to maintain any property in the City of Johnstown. The City is working with the County to develop a plan and the funding dollars to ensure that the properties are maintained during the summer.
- Ms. Daly added that 36 of the 73 code complaints were vacant and received a vacant letter. Six have been returned already. One person has called to say they are not vacant. One is deceased. Four have been returned with their \$500 fee and application. She stated there was 31 court hearings alone the week prior. Some were code violations and some were vacant properties. Of those, six were in compliance at the time of their date, five were continued, and 20 were found guilty. Those guilty pleas will equal \$14,725 back to the City. She is working with a follow up of unpaid fees and fines and contemplating going after them via a third party. She will present to Council in January or February on the matters. She then answered questions from Council on economic development.

REPORT OF POLICE CHIEF

Police Chief, Craig Foust discussed the cop grant. He has contacted the two guys on the civil service list and offered conditional employment. The police department is also pursuing private funds and donations to update technology.

REPORT OF PUBLIC WORKS DIRECTOR

Public Works Director, Darby Sprincz, thanked Mr. Gunby for his efforts with the lease program to obtain new equipment.

REPORT ON PRIOR YEARS AUDIT FINDINGS

Mr. Gunby reported on closing out the year and starting the process all over again.
