# JOHNSTOWN CITY COUNCIL MINUTES Wednesday, December 14, 2016

- City Council met in a stated session for the general transaction of business. Mayor Frank Janakovic called the meeting to order at 6:00 p.m. Interim City Manager Melissa Komar offered the invocation, and the Pledge of Allegiance was recited.
- Mayor Janakovic noted an Executive Session was held on December 6, 2016, prior to the commencement of the Special Council Meeting to discuss litigation and personnel issues.

#### PROCLAMATIONS, AWARDS, HONORS, RESOLUTIONS OF RECOGNITION:

- Daniel Schrader was sworn in as the newest member of the Johnstown Police Department.
- Mayor Janakovic announced on behalf of Councilmembers that there will be no real estate or other tax increase for the 2017 Budget. He thanked Budget Director Steve Keith, Interim City Manager Melissa Komar, Economic Development Director, Renee Daly and all City employees for assisting and cooperating to achieve this outcome. The Mayor noted the collective effort on all parts, including City Council members.

Mayor Janakovic noted the receipt of Interim City Manager Melissa Komar's resignation effective December 30, 2016. Best of luck was extended to her in all her future endeavors. Mr. Vitovich and members of Council extended congratulations and best wishes to Mrs. Komar.

The Mayor noted that contract negotiations for a new City Manager were in the final stages to become effective Tuesday, January 3, 2017.

#### PUBLIC COMMENT ON AGENDA ITEMS ONLY

James Brown, 391 Piney Place, Johnstown, addressed Council with regard to Bill No. 41, which had been previously tabled. Mr. Brown discussed his opinions regarding consolidation. He asked that Council "work together" and wished all a Merry Christmas.

### REPORT BY CITY MANAGER

Melissa Komar, Interim City Manager, reported that the Finance Department worked closely with various insurance companies to reduce the Workers' Compensation insurance premiums. She noted the budget on the agenda for amendment.

Mrs. Komar noted the Fire Department quickly contained recent fires in Oakhurst, Prospect, and Old Conemaugh Borough. She further noted members are being trained on hazardous materials updates.

It was noted the Johnstown Police Department participated in stated-funded Aggressive Driver and Buckle Up PA traffic enforcement programs. The Department maintains its involvement in the Cambria County Drug Coalition and the Victim Services Group regarding human trafficking and the sexual assault response team. Mrs. Komar noted that Captain Janciga was requested to participate in a televised special on gun violence in February at WPSU, University Park.

Mrs. Komar noted the Public Works repairs completed on the Sixth Avenue Bridge walkway. Shifts will commence to provide snow removal throughout the evenings and overnight.

The City Manager reported that the DCED staff met with a preservation organization regarding the demolition process for historically significant neighborhoods and buildings. Documentation will be submitted with the demolition request.

Mrs. Komar noted the City's residential rehab program provided \$461,000 worth of housing and rehab projects between January and December, including 16 owner-occupied first-time home buyer, 1 rental rehab, and 3 emergency rehabs.

It was noted that Johnstown will be hosting the 2017 Annual Action Plan Public Hearing on Monday, December 19, 2016, at five o'clock in anticipation of 2017 funds in March.

Mr. Williams requested an additional explanation regarding the insurance premium reductions. Mrs. Komar noted a \$200,000 savings as a result of negotiations.

Mrs. Stanton requested an update regarding the sidewalks on Sell Street. Mrs. Komar noted that no response had been received from Continental Construction.

### REPORT BY THE MAYOR

Frank Janakovic, Mayor, reported on attending the Moxham Light Up Night on December 2, 2016, with members of UPJ and Doctor Spectar.

Captain Janciga thanked Vested Interest in K9s Incorporated for their donation of vests. He also thanked the community for supporting the canine unit throughout the years.

The Mayor thanked all who were involved in the numerous Budget meetings and interviews for City Manager.

Mayor Janakovic was invited to participate in the Cambria County Steering Committee, which is a group of mayors and councilmembers, business people and citizens within the county who work together on a regional plan for the area.

- Mr. Vitovich discussed the Johnstown Housing Authority planning and recycling meeting held on December 1, 2016. Canisters will be ordered based on need. Flyers will be distributed to residents on a date to be determined.
