JOHNSTOWN CITY COUNCIL MINUTES Wednesday, December 9, 2015

City Council met in a stated session for the general transaction of business. Mayor Frank Janakovic called the meeting to order at 6:10 p.m. Assistant City Manager Melissa Komar offered the invocation, and the Pledge of Allegiance was recited.

Mayor Janakovic announced that Executive Sessions were held on December 1, 2015, December 4, 2015 and December 9, 2015, with regard to personnel issues.

The following members of Council were present for roll call:

Mr. Gentile, Mayor Janakovic, Mr. Johncola, Mr. Mickel, Mrs. Mock, Mr. Vitovich, Mr. Vizza (7).

City Solicitor David Andrews and Interim City Manager Melissa Komar were also present.

APPROVAL OF MINUTES

Mr. Vitovich made a motion to approve the Minutes of the two October 30, 2015 special meetings, the November 10, 2015 regular meeting, and the November 12, 2015 special meeting. The motion was seconded by Mrs. Mock and passed by the following vote:

Mayor Janakovic read the following comment into the record: As a result of our Executive Session, we wish to inform everyone that Council will consider a motion to turn over all information regarding Carlos Gunby to the law enforcement authorities, including the District Attorney of Cambria County. He noted a resolution will follow with regard to that motion.

COURTESY OF THE FLOOR

Joseph DeBartola, 1197 Bedford Street, Johnstown, addressed Council concerning local government. He discussed Council bringing the City into the future by "dealing with nepotism". He suggested using the language in Senator Wozniak's state bill with regard to the City's policy on nepotism. He suggested the City recruit the help of others to "build a new Johnstown" and bring about change. Mr. DeBartola further expressed the importance of

promoting the public's involvement in "building" Johnstown, not for their own self-interest but for the betterment of Johnstown itself. He suggested that Council meet with the Johnstown Redevelopment Authority to let them know that Council will not tolerate corruption in any form.

Mr. DeBartola stated he looks forward to hearing the ideas that Mr. Williams and Ms. Stanton have to move the City forward.

- Jack Williams, 360 Corinne Street, Johnstown, spoke to Council with regard to Bill No. 29 on the agenda. He had previously inquired if this bill in any way would affect Mr. Gentile's property on Cooper Avenue. Mr. Williams asked Attorney Andrews to insure the Coopersdale citizens that this does not in any way circumvent the progress in Coopersdale right now.
- Attorney Andrews deferred the question to Ms. Daly who noted the current zoning with regard to that property will remain the same.
- Mr. Williams referred to the Special Topics section of the agenda, noting the Administrative Code had not been amended to specify the Special Topics. He expressed the opinion that Council circumvented the Courtesy of the Floor, which he will discuss further at another time. Mr. Williams referred to Bill No. 31 on the agenda, which amends the Administrative Code regarding ordinances and resolutions. He stated that Council added this Special Topics section with no authority. He asked Council to follow the rules and regulations.
- Attorney Andrews explained he had a conversation with Mr. Williams with regard to the matter. Attorney Andrews stated it is not the intent of Council to circumvent any issue of public comment. Mr. Williams can raise the issue in January with regard to amending the Administrative Code. Attorney Andrews explained that Council has the right to invite individuals who may have something meaningful to present to the City, even though they may not be residents, at the invitation of Council. Amending the Administrative Code is currently a topic of discussion among Council members.
- Joseph Warhul, 44 Clover Street, Johnstown, addressed the issue of corruption and how "the City seems to work". Mr. Warhul stated he was at City Hall on November 20, 2015, to purchase statements of financial interest and further stated that within two hours, what he did and who he met with was on the internet. He stated that he finds it appalling that two city officials commented that he was "stealing", naming Mrs. Mock as one of the two individuals.

Mr. Warhul commented with regard to the EADS Group contributing \$1,800 in campaign funds. He called it the same EADS Group that "gave gifts to Mr. Repak". Mr. Warhul commented that now we have a city manager "in disgrace" at this point. Mr. Warhul suggested placing Mr. Gunby on administrative leave without pay until the matter is resolved. He further suggested that Mr. Gunby "should have been fired and not given the opportunity to resign."

Mayor Janakovic added that Mr. Gunby's resignation has not been officially accepted.

Donald McLean, 771 Central Avenue, Johnstown, addressed Council with regard to nearby homes with bricks falling down from deteriorating chimneys onto his properties. He noted rats have become a problem. Mr. McLean stated the City codes employee "will not do nothing about this." He provided photographs of his properties for Council to review. Mr. McLean noted the tree matter that he addressed at previous Council meetings has been resolved, but the house "is just sitting there rotting."

Mr. Janakovic requested that Interim City Manager Melissa Komar investigate the matter further and provide Council with a report on same.

Mr. Mickel asked Ms. Daly to address the issue since the matter had been brought up a few months ago.

Charlene Stanton, 184 Sell Street, Johnstown, addressed Council with regard to the City's current dilemma. She referred to issues such as Mr. Gunby's resignation and the missing City funds, murders, drugs, free passes, special privileges, the sewage fiasco, gift certificates from EADS to Council members, Council refusing to let a retired Johnstown police officer speak at Council meetings, Council flagrantly violating the Administrative Code by permitting Special Topics as an agenda item, hundreds of thousands of dollars in loans given to businesses, which were written off or are currently delinquent, as well as Council's \$10,000 giveaway for the Vision 2025 study. She also made reference to Councilwoman Mock's treatment of residents at Council meetings. Mr. Vitovich noted for the record that he has never received a gift certificate from the EADS Group. Mayor Janakovic added that "many of us haven't." He noted that Ms. Stanton "can help Council address all these issues come January."

Reverend Richard Williams, 752 Menoher Boulevard, Johnstown, addressed Council with regard to vacant lots being taken by ACRP. Mayor Janakovic stated that, as President and CEO of ACRP, he will be glad to meet with Mr. Williams at 131 Market Street for further discussion. Reverend Williams inquired if the

City of Johnstown had anything to do with tearing the houses down, clearing the lot and then giving it to ACRP. He noted that if this is happening, he "wants to put a stop to it." Reverend Williams spoke about the Christmas tree in the West End, noting that it was "put up" by Public Works. Mrs. Mock stated the West End Improvement Group paid Public Works for their time and offered to show Reverend Williams the cancelled check.

Mayor Janakovic responded to Referend Williams' comments by stating that over 250 families have been given housing, as well as help with doors, windows and food. He stated that "if that's a bad thing, Mr. Williams, I'm guilty," and the property has not been given to ACRP despite his comments.

SPECIAL TOPICS

Ed Sheehan, President and CEO Concurrent Technologies, Corporation, 100 CTC Drive, Johnstown, updated Council with regard to the work of the Vision 2025. He provided a brief history of the Vision Group and the specific categories which would be focused on, including government, economy, environment, and society. Mr. Sheehan stated that over 175 persons attended the last meeting held on November 16, 2015, at the Lutheran Church downtown. He noted that since that time, meeting dates have been set for the next meetings in January, and a marketing and a communications committee has been formed. Information will be sent to the Tribune-Democrat over the holidays to inform visitors of the status and focus of Vision 2025. Mr. Sheehan thanked Council for its support of Vision 2025.

On behalf of City Council, Mayor Janakovic thanked Mr. Sheehan and those involved with Vision 2025 for their support in moving the City forward.

Ron Shawley, 172 Albaugh Park Road, Johnstown, representing Laurel Highlands Historical Village, presented Council with a Certificate of Recognition. He noted the Honan Avenue project has received national recognition and commended the local businesses which volunteered manpower and equipment for the project.

Mr. Mickel made a motion to turn over findings with regard to Carlos Gunby to the proper authorities. The motion was seconded by Mrs. Mock.

Mayor Janakovic clarified the motion to mean proper law enforcement authorities.

REPORT BY THE CITY MANAGER

Melissa Komar, Interim City Manager, thanked the City, County and State emergency services for their coordinating efforts during the funeral service for Officer Reed of St. Clair Township.

Ms. Komar thanked the Moxham Renaissance Group and the University of Pittsburgh at Johnstown for coordinating the Light-Up Night at the Park Avenue Playground. She also thanked Discover Downtown Johnstown partnership for the tree lighting and all involved in the Christmas Parade. Ms. Komar further thanked the West End Improvement Group for their Christmas Parade and the Veterans Day Parade.

She recognized the Vision 2025 Group as a true example of many citizens coming together in the best interest of the community.

Ms. Komar noted the Haynes Street, Dellwood Street, and Prospect Viaduct projects have all been completed.

Ms. Komar congratulated the Johnstown High Football Team for becoming the District 6 AAA championship football team.

REPORT BY THE MAYOR

- Frank Janakovic, Mayor, reported on attending the Pennsylvania/West Virginia Roundtable at the Holiday Inn with regard to energy and controls, mining and coal usage. He thanked everyone who participated.
- Mayor Janakovic reported on recently attending the Veterans Day Parade. He reported on his meeting with Cambria County Commissioner Thomas Chernisky and Commissioner Elect B.J. Smith with regard to further discussion and coordination of City/County projects.
- Mayor Janakovic noted a special meeting will be held on December 14, 2015, with regard to the LST (Local Service Tax). He is requesting that the state and Act 47 offer other alternatives "to deal with our citizens and how we tax them and not be mandated one way or the other."
- The Mayor reported on meeting with students throughout the area as well as the previous City Manager and Representative Barbin with regard to their ideas for the future. Mayor Janakovic thanked the <u>Tribune-Democrat</u> for reporting

Mayor Janakovic on behalf of Council and the Solicitor presented certificates of recognition to both Mr. Mickel and Mr. Gentile for their service to the City of Johnstown.
