JOHNSTOWN CITY COUNCIL MINUTES Wednesday, April 8, 2015

- Prior to the commencement of the meeting, Mayor Janakovic, on behalf of City Council, expressed his sympathy to former Councilman Anthony Pinizzotto on the loss of his wife, followed by silent reflection.
- City Council met in a stated session for the general transaction of business. Mayor Frank Janakovic called the meeting to order at 6:00 p.m. City Manager Carlos Gunby offered the invocation, and the Pledge of Allegiance was recited.
- The following members of Council were present for roll call:

Mr. Gentile, Mayor Janakovic, Mr. Johncola, Mr. Mickel, Mrs. Mock, Mr. Vitovich, Mr. Vizza (7).

City Solicitor David Andrews, City Manager Carlos Gunby, Frank D'Ettorre, Dan Beyer, Andrew Fedorko, County Commissioner Lengenfelder, County Commissioner Wissinger, and County Commissioner Chernisky were also present.

APPROVAL OF MINUTES

Mr. Vitovich made a motion to approve the Minutes of the March 11, 2015 meeting. The motion was seconded by Mr. Mickel and passed by the following vote:

Mr. Gentile, Mayor Janakovic, Mr. Johncola, Mr. Mickel, Mrs. Mock, Mr. Vitovich, Mr. Vizza (7).

COURTESY OF THE FLOOR

Bill Polacek, 84 Iron Street, Johnstown, addressed Council with regard to a proposal by the business community to help create a vision for the City of Johnstown. Mr. Polacek asked Council to contribute \$10,000 towards the \$60,000 plan. He noted that \$40,000 has been received from the Community Foundation and \$5,000 has been donated by CTC. He congratulated Council for bringing an effective collaborative government to the City, something which he states "has not been seen for a long time." Mr. Polacek commented that this all started with meetings with prior city manager, Kristen Denne, Glenn Wilson and Ed Sheehan, the Johnstown Redevelopment Authority as well as JARI. He stated Congressman Murtha "really laid the foundation" to enable the region to continue moving forward. Mrs. Murtha could not attend tonight's meeting but expressed her support.

Mr. Polacek discussed future projects within the "vision" and the means by which the funding will be obtained. He noted the plan will assist Act 47 and move the City towards growth.

- Mayor Janakovic thanked the business community, elected officials, citizens and the Community Foundation for their joint efforts.
- Homer Mattes, 1160 Milford Street, Johnstown, addressed Council with regard to the City Dog Ordinance. He is a volunteer at the Sandyvale Memorial Gardens and extended an invitation to everyone to walk in the gardens, as well as their pets in the fenced-in dog park.

Mr. Mattes expressed a concern that the dog laws may need updated with regard to pit bulls and the pit bull mix. He proposed that the dogs should be tagged and registered with the City, and that up-to-date shot records and liability insurance be available. He suggested a 2-dog limit and that all dogs be spayed or neutered. He discussed additional updates for the dog laws.

Karen Senft, 828 Von Lunen Road, Johnstown, addressed Council with regard to the lack of police protection and street cleaning on the City side of Von Lunen Road. She has installed cameras and changed her locks at her residence due to multiple robberies. She commented that in emergency situations, Dale Borough responds and not the City police. Ms. Senft discussed the drug problems in her neighborhood and the retaliation against her family because she did "come forward" with names and places. She referred to a rental property near her home where there is drug activity. She noted she pays taxes to the City and urged the City police to patrol Von Lunen Road.

Ms. Senft has lived on Von Lunen Road for 11 years and has not seen a street cleaner once. She stated the street is filled with debris, glass and garbage. She requested that the street be cleaned.

- Mayor Janakovic requested that Chief Foust check into the matter further. The Mayor will discuss with Mr. Sprincz the cleaning of Von Lunen Road.
- Mrs. Mock asked Ms. Daly to investigate the matter further with regard to ownership of the rental property referred to by Ms. Senft.
- Joe Warhul, 44 Clover Street, Johnstown, addressed Council with regard to codes. Mr. Warhul has left messages with the Codes Department, and his calls are

> not returned. He questioned why a code violation is addressed faster when reported by a City official than by a resident. Mr. Warhul noted numerous code violations in his neighborhood that are not being addressed. He further noted he is not in favor of bureaucracy to solve problems. Mr. Warhul also discussed the misuse of building permits. He referred to properties in his neighborhood with overgrown hedges and weeds.

Mayor Janakovic asked that the matter be investigated further.

Charlene Stanton, 184 Sell Street, Johnstown, addressed Council with regard to city government. Ms. Stanton specifically discussed the time limit for Courtesy of the Floor and the fact that some speakers are given more time than others. She referred to a petition by Jack Williams with regard to this matter, which will be decided by the voters on the May ballot.

Ms. Stanton commented on the attestation she received with regard to written code complaints submitted by Council in 2014. She further commented with regard to the code complaint forms composed by Jack Williams.

She referred to the sewage work underway in Woodvale and requested clarification with regard to the sewage costs to homeowners. Ms. Stanton referred to comments by Councilwoman Mock regarding the clean-up of blighted homes on private property. Ms. Stanton inquired as to who would be responsible for injuries if residents were permitted to assist with the clean-up of these private properties. She suggested the use of the court system for noncompliance.

Mrs. Mock noted a quote directly from the codes enforcer and Ms. Daly confirmed the email from him.

REPORT BY THE CITY MANAGER

- City Manager Carlos Gunby, on behalf of City Council and the City employees, extended his deepest sympathies to the James "Jimbo" Peracchino Family.
- Mr. Gunby noted a unity peace march against crime and violence will be held May 8, 2015, beginning at 4:30 p.m. at the Greater Johnstown High School followed by a brief ceremony at 7:00 p.m. at the Point Stadium.
- Mr. Gunby stated that East Coast Baseball League games will be hosted at the Point Stadium.

- The City Manager reported the State of the City Address was held on March 19, 2015. He stated the PowerPoint presentation is available online. A video of the event will be available online in the near future. He thanked Sally Sargent for providing a video of the event at no cost to the City.
- Mr. Gunby attended a presentation at the Greater Johnstown High School along with Chief Foust and Officer Chad Miller honoring a freshman student for his actions when shots were fired at an incident in Moxham.
- Mr. Gunby noted the Pioneer Baseball League has requested approval of possible ownership of a Johnstown team. He stated further discussions will be scheduled regarding a long-term lease and ownership. Additional information will be provided to Council in the future.
- The City Manager welcomed Thor to the canine force of the Johnstown Police Department and thanked those responsible for his arrival.
- Mr. Mickel requested reports with regard to the status of the various loans administered by the City.
- Mr. Vitovich congratulated Chairman Sylvia King on her initiative to conduct meetings for the upcoming peace march.

REPORT BY THE MAYOR

- Mayor Janakovic continues to be involved with many groups, such as Creator Square, meetings with UPJ, Carnegie Mellon, Vision Committee, the hospital, Chamber of Commerce, and other organizations trying to improve the City.
- The Mayor noted a proclamation presented to Beginnings with regard to National Child Abuse Month. He further noted that April is National Autism Awareness Month.
- Mayor Janakovic and Mr. Gunby "relayed their message" to over 200 people that attended the State of the City Address last month.
- The Mayor discussed community volunteerism. He noted that for many years he has dealt with vacant lot issues and commended others in the community who are out there looking for codes violations. Mayor Janakovic stated it is a "massive job" and "it's time we roll up our sleeves." He stated that all help is appreciated.

- Mr. Mickel requested clarification with regard to Mr. DiBartola's request for a proclamation. Mr. Gunby noted that information has been gathered to move forward with a proclamation. Attorney Andrews stated the matter will be brought before Council for a vote.
- Mr. Vizza requested the revenue status with regard to Duke LifePoint. Mr. Gunby stated the tax bills are out and the accounts revenue columns for 2015 are significantly higher than in 2014.
- Mayor Janakovic stated there have been regular meetings with officials from the hospital. Attorney Andrews has been meeting with the County Solicitor as well.
- Mr. Mickel discussed the height of the basketball hoops at the Park Avenue Playground. Mr. Gunby stated all of the playgrounds are being reevaluated. Mayor Janakovic has spoken to Mike Kane and hopes to resurrect the Get Going in Moxham Project.
- Mrs. Mock requested an update on the new equipment. Mr. Gunby stated the equipment is starting to arrive. He stated that out of the savings from his initial estimates a new street sweeper will be purchased from A&H Equipment Company at a cost of around \$135,000 without impact on the budget. He stated, however, that the sweeper has not officially been purchased as it must first be approved by Council.
- Mayor Janakovic stated a second sweeper will help to rectify the street cleaning issues previously noted.

REPORT BY THE CITY SOLICITOR

David Andrews, Esquire, Solicitor, asked for Council's approval of a settlement of a tax assessment appeal case pending in Cambria County Court involving a property owned by Sara Ann Sargent on Walnut Street. He stated that he, the County Solicitor, and the Greater Johnstown School District Solicitor have all agreed on a value for settlement of the case for the vacant lot on Walnut Street. Attorney Andrews stated the revised assessed value is \$4,320.

Attorney Andrews read the resolution into the record as follows:

RESOLUTION NO. 9739

- Mr. Gentile made a motion to approve. The motion was seconded by Mr. Mickel and passed by the following vote:

- With regard to the street sweeper, Mr. Gunby read a resolution into the record as follows:

RESOLUTION NO. 9740

- A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JOHNSTOWN TO ALLOW THE CITY MANAGER AND THE SOLICITOR TO MOVE FORWARD AND SIGN AN AGREEMENT WITH A&H EQUIPMENT CO. TO PURCHASE A PELICAN STREET SWEEPER AT A COST OF APPROXIMATELY \$135,000.
- Mr. Vitovich made a motion to approve. The motion was seconded by Mrs. Mock and passed by the following vote:
 - Yeas: Mr. Johncola, Mr. Mickel, Mrs. Mock, Mr. Vitovich, Mr. Vizza, Mr. Gentile, Mayor Janakovic (7).Nays: None (0).
- Mr. Gunby noted that \$10,000 necessary to repair the hydraulics in the old sweeper

will be put towards the purchase of a new street sweeper.

REPORT BY THE CITY ENGINEER

- City Engineer Andrew Fedorko distributed a copy of his report to all members. He discussed the repair contract awarded to L&M Excavating, which is relocating a sanitary sewer on Haynes Street.
- Mr. Fedorko noted that Roxbury Phase One will restore the parking area in time for baseball season. Mr. Fedorko stated that Rutledge Place, Fox Alley, Lee Place will be paved this month. He noted that final notice door hangers for nonresponding property owners have been distributed in the Roxbury area.
- With regard to the Oakhurst Phase One Project, Mr. Fedorko noted that 73 percent of the pipe installation has been completed on contract one and 22 percent on contract two.
- Mr. Fedorko stated that 38 percent of the pipe installation has been completed with regard to the Woodvale/Prospect Project. He noted that Continental Construction is approximately 32 percent complete with pipe installation on the Prospect Project.
- Mr. Fedorko commented that he continues to meet with Oakhurst and Woodvale property owners with regard to connecting to the new sanitary system or capping and marking a new lateral in a location that would best fit their needs and, in some cases, can be a lot cheaper for the property owner. He offered his assurance that nothing illegal is being done with the connections and DEP is well aware of the status of the projects.
- The City Engineer stated that bids are open with regard to the Moxham Phase One Project and noted Continental Construction and Kukurin Contracting as the low bidders. He further stated construction will start in June of 2015.
- Mr. Fedorko reported that the Woodvale/Oakhurst laterals is a joint construction project with JRA and involves two separate PennVEST loans, which is scheduled to commence in October of 2015.
- With regard to violation enforcement, pressure testing on property transfers became effective as of April 1st, 2015.
- The City Engineer noted the EADS Group has contacted R.W. Sidley to provide a cost estimate with regard to the components that have deteriorated in the Lincoln Street Garage.

- Mr. Fedorko reported that cost estimates are being prepared for some deteriorated channel walls near 521-523 Russell Avenue and the Moskal Funeral Home.
- There was discussion with regard to a newspaper article and problems with Kukurin Contracting and the Cambria/Somerset Authority for work done at the Que.
- Mr. Gentile questioned Dan Beyer with regard to grants being obtained for Russell Avenue and Moskal Funeral Home. Mr. Beyer noted a determination should be made by September/October. He noted these would be projects for next year.
- Mr. Vitovich inquired if the gabion cages will be replaced with new ones. Mr. Beyer answered that the cages would not be replaced.
- Mrs. Mock asked Mr. Fedorko whether the manhole issues were resolved. Mr. Fedorko stated once the frost has dissipated from the ground, all the low manholes, grates, and inlets will be adjusted accordingly. He further noted the slag backfill material, compared to limestone, will save the City approximately \$5 million in construction until the projects are completed.
- Mr. Gunby commented that there are \$10.9 million worth of PennVEST applications. He is trying to conserve monies and incorporate the needed changes at a reasonable cost.
- Mr. Fedorko stated any street problem areas will be milled and repaved. Mr. Gunby clarified that paving will be done curb to curb in sections impacted by the project. Mr. Fedorko stated the City is spending approximately \$500,000 per project outside of the ditch.
- Mr. Gentile inquired as to the status of the sewer lids that were lifted on Broad Street, Strayer Street, and Fairfield Avenue. Mr. D'Ettorre stated the issues with the lifted sewer lids will be resolved.

REPORT OF POLICE CHIEF

Chief Craig Foust noted his comments were covered under the Report by the City Manager.

REPORT ON ECONOMIC DEVELOPMENT

Renee Daly, Economic Development Director, reported that Administrative Assistant Marlane Zima will be retiring on May 11, 2015, and noted that there are currently 17 applications for her position, which will be filled by the end of the month.

Ms. Daly is awaiting results of a HUD audit monitoring and noted HUD seemed pleased with the CHODO or housing development through the county. She stated that Department of Health monitoring for lead based paint came back with no findings for the first time in seven years.

Ms. Daly stated the Farmers' Market (Downtown) will begin on Friday, May 8, 2015, from 9:00 a.m. to 2:00 p.m. and the West End Farmers' Market (Senior Life) will begin on Tuesday, June 9, 2015, from 3:00 p.m. to 6:00 p.m.

She noted a public meeting was held on March 19, 2015, with regard to the Cambria City Phase II master plan and stated notification should be received by the end of the month as to additional funding.

- Mr. Gentile requested an update with regard to the apartment complex on Boyer Street in Coopersdale. Ms. Daly stated several locations have been submitted for PHFA and noted the state must approve the possible historic building. Once approval is given and the funds are released, the matter can move forward.
- Mr. Vizza asked Ms. Daly and her department to investigate the 700 block of Highland Avenue where cars are scattered around a business and also, the small industrial park at Oak and Murdock Street in Hornerstown that is being turned into a landfill.

COUNCIL COMMITTEE/NEIGHBORHOOD LIAISON REPORTS

Mrs. Mock thanked Chief Foust and the Johnstown PD for apprehending a person who was doing the graffiti damage in the West End. She noted the West End Improvement Group has thus far raised over \$12,000 for cameras and further noted an anonymous donation of \$2,000.

Mrs. Mock stated a meeting was held with Dectective Kevin Price of the Drug Task Force, Chief Foust, Mr. Gunby, Councilmembers, and neighborhood residents with regard to installation of the cameras.

- Mr. Mickel stated the Roxbury Civic Group agreed at its last meeting to start the second phase of camera installation at the Roxbury Park. Mr. Mickel recognized the Moxham group for patrolling the Park Avenue Playground since the shooting on March 22, 2015, in an attempt to "take back their neighborhood."
- Mr. Vitovich congratulated Mrs. Mock for receiving the YWCA Tribute to Women Yellow Rose Award.
- Mr. Vizza welcomed the Freight Station, a new restaurant in downtown Johnstown located at 20 Matthew Street near the Gautier mill gate that will open April 11, 2015.
- Mayor Janakovic stated that UPJ in partnership with the City and some grants is sponsoring a Night Life event on Saturday, April 11, 2015, from 6:00 p.m. to 2:00 a.m. for UPJ students who will be bussed to the downtown area, Roxbury and Cambria City. He hopes that by next fall the Transit Authority will have a regular route in place to transport the students to downtown.
- Mr. Johncola stated that City maps will be reviewed with the EADS Group following the meeting. Mr. Johncola recently attended and enjoyed Fight Night at the Bulldog Arena.
- Mr. Gentile noted a new backhoe was recently purchased. He commended the Fire Department for their quick action at a recent motorcycle accident on Beatrice Avenue in the West End.
