AND PENSION FUND OBLIGATIONS OF THE CITY OF JOHNSTOWN, PENNSYLVANIA, FOR THE CALENDAR YEAR BEGINNING JANUARY 1, 2016, INCLUDING THE FOLLOWING CITY OF JOHNSTOWN FUND SECTIONS AND THE RESPECTIVE FUNDS "BUDGET EXHIBIT A DETAILS" TO CORRECT ERRORS AND OMISSIONS WITH THE AMENDING AND FINAL PASSAGE OF ORDINANCE NO. 5192 ON DECEMBER 22, 2015.

Mr. Vitovich made a motion to approve the ordinance. The motion was seconded by Mrs. Mock.

Mr. Williams explained Council failed to adopt a spending plan for the year. He noted that last year's budget was presented on November 10, 2015, Bill No. 25 of 2015, which Council adopted by resolution, which he noted as improper stating an ordinance can only be amended by another ordinance.

Mr. Williams stated that on December 22, 2015, Council held the required public hearing and adopted Bill 5192, which the solicitor had agreed was invalid. From then until the present day, the City sent property taxes out based on the adoption of Ordinance 5192, which was improper. The City in late December borrowed up to \$3 million from 1st Summit Bank as a tax anticipation note, which is money to be used until the receipt of the real estate taxes. He indicated the note was predicated on the City having a balanced and adopted budget, which it did not. Mr. Williams discussed the work in Central Park for electrical upgrades. The City's Charter of May 18 1993 stipulates the financial procedures that must be adopted, of which the Capital fund is included. Every year administration is required to submit to Council a capital budget for the following year, which was not done.

Mr. Williams indicated Council approved a resolution authorizing work up to \$52,000 for electrical work with no money appropriated for that purpose. The process will now commence for putting a 2016 budget in place, ten days for public inspection. Council will be required to hold another hearing for final adoption. He noted the 2015 budget had no appropriation for the electrical work.

Mr. Williams discussed his review of monthly finance reports that reflect at least six general fund accounts already in the red. The Charter states, the City shall not incur any obligation or make any payments unless it has been duly appropriated in the budget with sufficient funds to pay for the debt. He indicated that Mrs. Komar will be presenting budget transfers to correct these deficit accounts. He and Mrs. Stanton will be monitoring all line items going forward. Mr. Williams discussed the property tax discount period. He urged

Council to read the Charter and plan on sitting as long as it takes to go through the 2017 budget.

Attorney Benjamin indicated the ordinance passed first reading and now will be advertised. A public hearing will be held prior to its final adoption. She suggested that Council should resolve the matter as soon as possible.

- Attorney Benjamin provided background information on the resolution. She noted this entity is a charitable organization currently exempt from taxation. When the property was purchased, there was an existing lien on the property by the prior owners. The County later removed the property from tax sale due to the organization's charitable status. Attorney Benjamin noted that in an effort to clear the title, the entity may have offered to pay 50 percent of the total amount owed in exchange for forgiveness. She explained this is a very unique situation, which may not repeat itself in the future.
- Mr. Williams commented by saying, what is to stop others who have delinquent taxes from coming in and asking for an exemption.
- Mayor Janakovic indicated these are extenuating circumstances and noted this is an exception.
- Mrs. Komar explained that the County agreed to remove the property from a tax sale and the School District has granted forgiveness. She further stated the entity has already paid 50 percent of the taxes and is requesting forgiveness of the other 50 percent.
- Mrs. Stanton noted if the exception is granted, others will request the same exemption.
- Mayor Janakovic commented this is a specialized nonprofit group as opposed to an individual household.

#### Resolution No. 5853

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JOHNSTOWN, PENNSYLVANIA, AUTHORIZING THE CITY MANAGER TO SIGN ALL DOCUMENTS NECESSARY TO EXECUTE TASK ORDER NO. 35 TO THE EADS GROUP, INCORPORATED, FOR THE PREPARATION OF FUNDING APPLICATIONS, PREPARATION OF PERMIT APPLICATIONS, ADMINISTRATION OF FUNDING AND INSPECTION SERVICES OF THE OHIO STREET SANITARY/STORM SEWER SEPARATION PROJECT.

Mr. Vizza made a motion to approve. The motion was seconded by Mr. Vitovich and passed by the following vote:

Mayor Janakovic made a motion to approve sewer lateral assistance reimbursement up to \$1,000 for property owners who pressure tested prior to funds being released for those who met the compliance requirements.

Mrs. Komar has been contacted by numerous property owners who met the income requirements but did not have access to funding at the time of compliance. Council members agreed to present a resolution at the next meeting with regard to the matter. Mr. Williams suggested a budget amendment. Mayor Janakovic suggested to follow the quickest resolve to the matter.

#### PUBLIC COMMENT ON NON-AGENDA ITEMS

- Michael Artim, 221 Central Avenue, Johnstown, updated Council with regard to Vision 2025. He discussed the three current projects, life-sustaining landscapes, vibrant local economy, and a strong sense of community. He stated river wall improvements are necessary to bring back the natural beauty of the landscape. Mr. Artim also discussed the necessity of neighborhood development and planning. He noted the 30 capture teams are comprised of 850 volunteers working on projects in these areas. He referred to available microgrants in an amount of up to \$1,000. Mr. Artim updated Council on additional ongoing projects.
- Scott Wilhelm, 197 Dormer Street, Park Hill, PA, addressed Council with regard to veteran suicide awareness and veteran suicide rate. His group is attempting to create funding to assist local veterans with getting needed help. He discussed scheduling a walk. Mr. Wilhelm may be contacted via email at deathreaper0228@gmail.com or by telephone at 814-243-3281.
- Mrs. Stanton thanked Mr. Wilhelm and all veterans for their service. She inquired whether Mr. Wilhelm's public comments as a non-City resident would be in violation of the City Code.
- Attorney Benjamin suggested that Council address the matter of non-City public speakers in the future.

John DeBartola, 1197 Bedford Street, asked Mrs. Stanton to clarify the hockey rink issue at Roxbury Park and her involvement with the matter. Mrs. Stanton explained the residents' safety concerns were forwarded to Mrs. Komar. Mrs. Komar then forwarded a response to Mrs. Stanton from Kim Struble, the City's building compliance officer, who stated a child was injured. Mrs. Stanton requested that signage be placed indicating the area is unsafe. She denied making slanderous comments as was noted.

Mr. DeBartola noted that Vison 2025 is willing to assemble a work crew to reconstruct the hockey rink. He asked Council to pass a motion or resolution with regard to the matter.

Mrs. Mock contacted the court administrator, who indicated that the "Judge has had it with Mrs. Stanton". He was tired of the county workers "being criticized for doing work to help them to get back into the community".

Mayor Janakovic stated the "work crew" has done substantial work for the City and nonprofits, and that "we do not want to lose that group". He suggested that the situation be rectified.

Mrs. Stanton noted it is the City's responsibility to make sure safety concerns are addressed.

1. May 12 letter from City of Johnstown Planning Commission.

Mayor Janakovic read the following public notices into the record as follows:

MRS. BARBER WISHES TO PUBLICLY DISCLOSE THAT SHE IS THE AUNT OF AN EMPLOYEE, SAMUEL BARBER, OF THE CITY OF JOHNSTOWN WHO SERVES AS THE CODE ENFORCEMENT OFFICER. THUS REGULATIONS WHICH GOVERN THE FEDERAL COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM, CDBG, REQUIRES THE CITY TO PROVIDE FULL PUBLIC DISCLOSURE TO CDBG EXPENDITURES WHICH MAY CONSTITUTE CONFLICT OF INTEREST. ACCORDINGLY THE CITY WILL REQUEST HUD TO

ISSUE AN EXEMPTION TO THE REGULATORY CONFLICT OF INTEREST PROHIBITION.

Mr. Williams made a motion to table the matter.

PUBLIC NOTICE, CITY OF JOHNSTOWN, COMMUNITY DEVELOPMENT BLOCK GRANT, NOTICE IS HEREBY GIVEN THAT THE CITY OF JOHNSTOWN IS CONSIDERING ENTERING INTO A CONTRACT WITH FRANCES AND LOUIS CUSTER UNDER THE EMERGENCY REHABILITATION OR OWNER/OCCUPIED LOAN PROGRAMS. MR. AND MRS. CUSTER WISH TO PUBLICLY DISCLOSE THAT THEY ARE THE AUNT AND UNCLE OF AN EMPLOYEE, SAMUEL BARBER, OF THE CITY OF JOHNSTOWN WHO SERVES AS THE CODES ENFORCEMENT OFFICER. THUS REGULATIONS WHICH GOVERN THE FEDERAL COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM (CDBG) REQUIRES THE CITY TO PROVIDE FULL PUBLIC DISCLOSE TO CDBG EXPENDITURES WHICH MAY CONSTITUTE CONFLICTS OF INTEREST. ACCORDINGLY THE CITY WILL REQUEST HUD TO ISSUE AN EXEMPTION TO THE REGULATORY CONFLICT OF INTEREST PROHIBITION.

Mr. Williams stated Council agreed to no Communications for this meeting. He made a motion to table the above matter until the next meeting. The motion was seconded by Mrs. Stanton.

Attorney Benjamin explained this was a public notification statement being read.

There was no matter to be tabled.
