**RESOLUTION NO. 10506**

**A RESOLUTION OF CITY COUNCIL OF THE CITY OF JOHNSTOWN, PENNSYLVANIA AUTHORIZING THE CITY MANAGER TO SIGN ALL DOCUMENTS NECESSARY TO EXECUTE AN AGREEMENT WITH CHARLES J. MERLO, INC. AWARDED CONTRACT 2022-01 FOR THE CONSTRUCTION OF THE SAM'S RUN FLOODWALL REPLACEMENT AND CHERRY RUN CHANNEL WALL REPLACEMENT PROJECT**

**WHEREAS**, the EADS Group Inc. on behalf of the City of Johnstown advertised and opened bids for the construction of the Sam's Run Floodwall Replacement and Cherry Run Channel Wall Replacement Project; and

**WHEREAS**, bids were advertised in a paper of general circulation and the bids were opened at 10:00 am on April 20, 2022; and

**WHEREAS**, Charles J. Merlo, Inc. is the apparent low bidder for Contract 2022-01, Sam's Run Floodwall Replacement and Cherry Run Channel Wall Replacement Project, with a Total Base Bid of \$678,250.00; and

**WHEREAS**, the City administration recommends that the City Council accept the attached proposal for said work, in the amount of \$678,250.00. Sam's Run \$344,185.75 will be paid from 18,489,285.46 Capital Fund and Cherry Run \$334,064.25 will be paid from 26,466,285.67 ARPA fund; and

**WHEREAS**, approval of an agreement based on the acceptance of the above referenced proposal shall be and is hereby made contingent upon final review and approval of all applicable terms and conditions by the City Solicitor.


