

**CITY OF JOHNSTOWN, PENNSYLVANIA
RESOLUTION NO. 10512**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JOHNSTOWN, CAMBRIA COUNTY, PENNSYLVANIA, AUTHORIZING THE CITY MANAGER AND FINANCE DIRECTOR TO SIGN ALL DOCUMENTS AND TAKE ANY/ALL OTHER ACTIONS NECESSARY IN THE PURCHASE AN 2023 2000 GPM PUMPER INSTALLED ON A SPARTAN MOTOR METRO STAR CAB AND CHASSIS FROM 4 GUYS STAINLESS TANK AND EQUIPMENT INC.

WHEREAS, the City of Johnstown Fire Department requires replacement of a Fire Service Pumper for the purpose of performing Structural Firefighter and Rescue Operations within the city of Johnstown; and

WHEREAS, The current Fire Service Pumper is being replaced as part of a department rotation of equipment for vehicles. The new vehicle will meet current NFPA standards; and

WHEREAS, Replacement of the Fire Service Pumper was budgeted for in the Capital Improvement Plan; and

WHEREAS, purchase of this Fire Service Pumper will be made from the Capital Fund Account; and

WHEREAS, through search and specification requirements of the Rescue/Engine Committee, 4 Guys Stainless Tank and Equipment Inc (4 Guys Fire Equipment) was picked based off of COSTAR price and meeting the committee specifications at a cost of \$695,478.00 that will be financed over ten years as in the Capital Improvement Plan.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of Johnstown, Cambria County, Pennsylvania, that the City Manager and Finance Director are hereby authorized to sign all documents and take any/all other actions necessary to purchase said 2023 2000GPM Pumper installed on a Spartan Motors Metro Star Cab and Cassis from 4 Guys Stainless Tank and Equipment Inc (4 Guys Fire Equipment) at a cost of \$695,478.00.
