RESOLUTION NO. 10530

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JOHNSTOWN, CAMBRIA COUNTY, PENNSYLVANIA, AUTHORIZING AND DIRECTING THE CITY MANAGER AND/OR HIS DESIGNEE(S) TO TAKE ANY/ALL ACTIONS NECESSARY TO EXECUTE A MEMORANDUM OF AGREEMENT WITH THE JOHNSTOWN AREA HERITAGE ASSOCIATION (JAHA) AND CAMBRIA COUNTY TRANSIT AUTHORITY (CAMTRAN) TO DETAIL RESPONSIBILITIES FOR EACH AGENCY WITH THE UNITED STATES DEPARTMENT OF TRANSPORTATION REBUILDING AMERICAN INFRASTRUCTURE WITH SUSTAINABILITY AND EQUITY (RAISE) PROJECT

WHEREAS, the City of Johnstown is the recipient of a FY 2021 United States Department of Transportation (USDOT) Rebuilding American Infrastructure with Sustainability and Equity (RAISE) grant; and

WHEREAS, the City RAISE grant involves projects at physical sites and locations owned by the City, JAHA, and CamTran; and

WHEREAS, per direction from the Federal Transit Administration, funding from the RAISE grant is not eligible to be utilized on the pre design stage of the project; and

WHEREAS, funding beyond what is available within the RAISE grant may be needed for these projects, especially with regard to the Section 106 and National Environmental Policy Act (NEPA) clearances; and

WHEREAS, all three agencies agree to providing funding needed beyond what is available within the RAISE grant for pre construction activities, engineering and construction of their specific projects; and

NOW, THEREFORE, BE IT RESOLVED, following review by the City Solicitor the City Manager and/or his designee is hereby authorized and directed to execute a Memorandum of Agreement (MOA) between the City, JAHA, and CamTran for costs associated with the FY 2021 USDOT RAISE grant.
