RESOLUTIONS:

Authorizing a Grant Application to the Pennsylvania Department of Conservation and Natural Resources - Council is asked to authorize a grant application to DCNR's Community Conservation Partnership Program in the amount of \$513,000. If approved, this funding will match the City's \$500,000 American Rescue Plan Act (ARPA) allocation for park improvements. The funds will be used to make improvements to Roxbury Park, Forest Avenue Park and Honan Avenue Park.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JOHNSTOWN, PENNSYLVANIA AUTHORIZING THE CITY MANAGER AND/OR HIS DESIGNEE TO SUBMIT A GRANT APPLICATION TO THE PENNSYLVANIA DEPARTMENT OF CONSERVATION AND NATURAL RESOURCES COMMUNITY CONSERVATION PARTNERSHIPS PROGRAM IN THE AMOUNT OF \$513,000 TO BE USED FOR CITY PARK IMPROVEMENTS AT FOREST AVENUE, HONAN AVENUE AND ROXBURY PARKS

<u>Recommended Action</u> - Make a motion to adopt the proposed Resolution authorizing City staff to file a grant application with the Pennsylvania Department of Conservation and Natural Resources.

Approving a Contract with LMJ Contractors to Construct a Press Box, Office Space and Concession Areas at Sargents Stadium at the Point - The City solicited bids for a project to construct a two story building at Point Stadium that will house office space, concession areas, and a press box. Four proposals were received from qualified bidders. The low bidder was LMJ Contractors with a bid price of \$283,750. Funds from the City's American Rescue Plan Act (ARPA) allocation to the stadium will pay the full cost of the project.

EXECUTE AN AGREEMENT WITH LMJ CONTRACTORS, INC TO CONSTRUCT A TWO STORY BUILDING AT SARGENTS STADIUM AT THE POINT

<u>Recommended Action</u> - Make a motion to approve a resolution authorizing the City Manager and/or his designee to enter into a contract with LMJ Contractors to construct a press box, concession area and office space at Sargents Stadium at the Point.
