## CITY OF JOHNSTOWN, CAMBRIA COUNTY, PENNSYLVANIA RESOLUTION NO.10630

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JOHNSTOWN, CAMBRIA COUNTY, PENNSYLVANIA AUTHORIZING THE CITY MANAGER TO SIGN ALL DOCUMENTS NECESSARY IN APPROVING AN AMENDMENT TO THE CONTRACT WITH PRO DISPOSAL, INC. FOR THE WEEKLY COLLECTION, DISPOSAL AND PROCESSING OF MUNICIPAL SOLID WASTE AND RECYCABLE MATERIALS AND WITH BULK ITEM/WHITE GOODS PICK-UP MONTHLY AND PROVIDING TEN (10) ROLL OFF DUMPSTERS FOR COMMUNITY SPRING CLEAN UP AND TEN (10) ROLL OFF DUMPSTERS FOR COMMUNITY FALL CLEAN UP. AMENDMENT SHALL TAKE EFFECT SEPTEMBER 1, 2024, AND REMAIN IN EFFECT UNTIL AUGUST 31, 2029.

WHEREAS, the City of Johnstown has previously entered into a contract with Pro Disposal, Inc. for the collection of solid waste and recycling collection service; and

WHEREAS, Pro Disposal, Inc. has agreed to provide ten (10) roll off dumpsters in the spring for community clean-up and this will consist of hauling for free and dumping under the PA Clean Ways. Pro Disposal, Inc. has agreed to provide ten (10) roll off dumpsters in the fall and this will consist of hauling costs and landfill costs; and

WHEREAS, Pro Disposal, Inc. will place the dumpsters throughout the City.

NOW, THEREFORE BE IT RESOLVED, CITY COUNCIL OF THE CITY OF JOHNSTOWN, PENNSYLVANIA AUTHROIZES THE CITY MANAGER TO SIGN ALL DOCUMENTS NECESSARY IN APPROVING AN AMENDMENT TO THE CONTRACT WITH PRO DISPOSAL, INC. FOR THE WEEKLY COLLECTION, DISPOSAL AND PROCESSING OF MUNICIPAL SOLID WASTE AND RECYCABLE MATERIALS AND WITH BULK ITEM/WHITE GOODS PICK-UP MONTHLY AND PROVIDING TEN (10) ROLL OFF DUMPSTERS FOR COMMUNITY SPRING CLEAN UP AND TEN (10) ROLL OFF DUMPSTERS FOR COMMUNITY FALL CLEAN UP. AMENDMENT SHALL TAKE EFFECT SEPTEMBER 1, 2024, AND REMAIN IN EFFECT UNTIL AUGUST 31, 2029.
