**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JOHNSTOWN,
PENNSYLVANIA, RESOLUTION AUTHORIZING THE ADDITION OF
FLEET MAINTENANCE MANAGER POSITION TO THE PUBLIC WORKS
DEPARTMENT**

WHEREAS, the City of Johnstown is committed to maintaining the highest standards of safety, functionality, and reliability in its public service fleets, including the vehicles utilized by the Police and Fire Departments; and

WHEREAS, the management of the city's fleet is integral to the operational efficiency of key public safety services, ensuring that all vehicles are properly maintained and prepared for use; and

WHEREAS, the current demands placed on the Public Works Department necessitate the addition of specialized personnel to oversee fleet maintenance operations, streamline processes, and develop robust preventive maintenance programs; and

WHEREAS, there is a pressing need for a dedicated Fleet Maintenance Manager who will bring expertise in vehicle maintenance, repair, and operational strategy to enhance the city's fleet management practices; and

WHEREAS, the estimated salary for the position of Fleet Maintenance Manager is \$67,500 annually; and

WHEREAS, this expenditure will be covered by reallocations from existing salaries within the Police and Fire Departments to ensure fiscal responsibility while advancing our service capabilities.

**NOW, THEREFORE, BE IT RESOLVED, by the City Council of Johnstown,
Pennsylvania, that:**

1. The position of Fleet Maintenance Manager is hereby authorized to be added to the Public Works Department effective immediately upon the passage of this resolution.
2. The annual salary for the position will be set at \$67,500.00, and funding for this position will be sourced from the existing salary budgets of the Police and Fire Departments.

3. City administration is instructed to initiate the recruitment process for the Fleet Maintenance Manager and report back to the City Council regarding progress and timeline.

BE IT FURTHER RESOLVED that this resolution takes effect immediately upon its adoption this 11th day of September 2024.
