**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JOHNSTOWN, PENNSYLVANIA  
ENTERING INTO AN AGREEMENT WITH BISHOP MCCORT CATHOLIC HIGH SCHOOL TO  
PROVIDE A SCHOOL RESOURCE OFFICER AND AUTHORIZING THE CITY MANAGER TO  
TAKE ALL ACTIONS NECESSARY TO EFFECTUATE THE SAME.**

**WHEREAS**, the City Council of the City of Johnstown, Pennsylvania finds it to be in the City's best interest to provide a School Resource Officer to Bishop McCort; and

**WHEREAS**, the City of Johnstown and Bishop Mccort desire to enter into an agreement for the City to provide a School Resource Officer to the District; and

**WHEREAS**, the terms of the agreement shall begin on August 18, 2025, and conclude on May 29, 2026; and

**WHEREAS**, the police officer at the high school/middle school shall perform his or her duties for the Bishop Mccort Catholic High School from 7:15AM until 3:15PM during the 157-day school year and will start on the date of the teachers return; and

**WHEREAS**, the city will be compensated by the School District \$52,752 for the 157-day school year for a school police officer understanding and agreeing that the relevant amounts shall be subject to an increase in January of each year equivalent to the percentage of increase in salary cost for the assigned officer as specified in the police collective bargaining agreement.

**NOW, THEREFORE, BE IT RESOLVED**, that the City Manager is hereby authorized and directed to execute, on behalf of the City of Johnstown, the attached agreement with Bishop McCort to provide School Resource Officers at Bishop McCort High School.

**BE IT FURTHER RESOLVED** that the City Manager and other appropriate City officials are authorized and directed to take all steps necessary to further effectuate the purpose of this Resolution.




