A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JOHNSTOWN, CAMBRIA COUNTY, PENNSYLVANIA, ACKNOWLEDGING RECEIPT OF AND AUTHORIZING THE CITY MANAGER AND/OR HIS DESIGNEE TO TAKE ANY/ALL ACTIONS NECESSARY TO INCLUDE THE CALCULATIONS OF THE MINIMUM MUNICIPAL OBLIGATION FOR EACH OF THE CITY'S PENSION FUNDS FOR INCLUSION IN THE 2026 MUNICIPAL BUDGET.

WHEREAS, Pennsylvania law requires the inclusion of certain Minimum Municipal Obligations for Municipal Employees' Pension Funds in a Municipality's budgetary planning; and

WHEREAS, Acrisure Benefits group has calculated the Minimum Municipal Obligation for each of the City Pension Funds as follows:

Firemen's Pension fund	MMO	\$491,054
Officers and Employees Pension fund	MMO	\$230,996
Sewage Pension Fund	MMO	\$21,512
Police Pension Fund	MMO	\$254,062
Total Minimum Municipal Obligation	MMO	\$997,624

WHEREAS, the Minimum Municipal Obligation calculations are attached and conform with the provisions of Chapter 3 of Act 205 of 1984; and

NOW, THEREFORE, BE IT RESOLVED by The City of Johnstown of Cambria County, Pennsylvania, that receipt of the Minimum Municipal Obligation for the 2026 City Budget is hereby acknowledged and that the City Manager and/or his designee is directed and authorized to take any/all actions necessary to include the calculations for the minimum Municipal Obligation for each of the City's Pension Funds in the 2026 Municipal Budget.

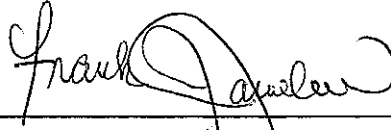

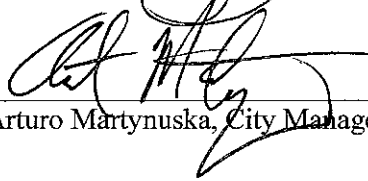
