A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JOHNSTOWN, PENNSYLVANIA, AUTHORIZING AND DIRECTING THE CITY MANAGER AND / OR ANY OF HIS DESIGNEES TO ENTER INTO AND TAKE TO EFFECTUATE A CONTRACT WITH WHOLESALE ENERGY COMPANY FOR THE PURPOSE OF DISCOUNTED ELECTRICITY.

WHEREAS, The Finance Director has determined that it would be in the City's interest to retain the services of EP&G as an independent energy consultant; and

WHEREAS, EP&G has demonstrated significant cost savings to the City by ability rules.

WHEREAS, the City's authorization for entering into an agreement with a wholesale supplier is contingent upon said agreement including a rate at/ around the level identified above, or lower, in order to effectuate the estimated savings; and

WHEREAS, any / all final actions taken to effectuate such an agreement shall remain contingent upon review and approval of the City Solicitor.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Johnstown, as follows:

The City approves entering a contract with Wholesale Energy Company for the purpose of procuring discounted electricity for the City of Johnstown and directs the City Manager to execute the necessary documents to effectuate the same.
