City Council met in a stated session for the general transaction of business.

Mayor Frank Janakovic called the meeting to order at 6:02 p.m.

Reverend King offered the invocation. The Pledge of Allegiance was recited.

**CITY MANAGER:** 

Daniel Penatzer, Interim City Manager, reported the 2022 Budget is scheduled to be presented at a special meeting on Wednesday, October 27, 2021 followed by a public hearing scheduled for November 10, 2021 just prior to the Council meeting.

As per the Pennsylvania UDAG loan disclosure regulation, which requires that a legal ad be placed in the newspaper to make the public aware that an employee has applied, Mr. Penatzer read the following into the record:

To Whom It May Concern: In the interest of transparency let it be known that Mr. Anthony Penna, City Employee, has applied for an Economic Development Loan under the City's UDAG loan program. Mr. Penna has provided all relevant documentation required as part of the loan application process, including a completed loan application. Mr. Penna had not been provided any, quote, inside information, end quote, related to the City's loan program. Applications for the City's loan programs are taken on a first-come, first-served basis and there is not currently a wait list nor any other pending applications. Mr. Penna is no way involved in the decision-making process of any of the City's loan programs nor does he have any interest of any kind with any members of the loan review committee. The public notice describing Mr. Penna's employment with the City as well as his intentions to seek an Economic Development Loan was published in the Tribune Democrat on Saturday, October 2, 2021. Respectfully, Jacob Zerby, Economic Development Specialist.

Mr. Penatzer announced that staff members of the Chamber of Commerce, Discover Downtown and other agencies are working together to sponsor the Halloween Parade which is schedule for Tuesday, October 26, 2021. A permanent group is being consider to handle parade details in the future.

Mr. Penatzer commented that he was unaware of the requirement, which requires the expenditure line item from the budget to be included in any resolution that authorizes an expenditure. He noted that the budget line item had been inserted into the formal resolutions to be signed with regard to Resolution Nos. 5 and 6 on the agenda and asked Council to approve the resolutions as amended. He noted further that there may be five or six earlier resolutions where an expenditure was appropriated, and he would consult Ms. Benjamin regarding the matter.

He noted that the iPads ordered for Council members have finally arrived and orientation would beheld with regard to use of the pads.

Mayor Janakovic commented that it was his understanding a Christmas Crawl would be held this year, and the dates and times would be announced. A Veteran's Day Parade would also be held.

A round of applause was held for Ms. Cushing who as announced by Mrs. Mock would be retiring soon.

# **MAYOR**

Mayor Frank Janakovic reported his attendance at a number of events this past month including Octoberfest at PNG Park, a press conference at the Clara Barton House with regard to fundraisers for renovations and the Ameriserv Music Fest at PNG Park.

Mr. Janakovic presented a proclamation recently at the Franklin Street Bridge dedication. He commended the Fire Department for making it a special event. The bridge was painted San Francisco Bridge red.

He noted his attendance at the Chamber Annual Dinner where the Johnstown Symphony was recognized.

He and several Council members attended some Vision 2025 meetings. Mr. Janakovic reporting that he attended the United Way Partner Meeting. He and several administrative staff members had discussion with Representative Rigby's Office and Representative Frank Burns with regard to the U.S. Steel project.

Mayor Janakovic and several Council members attended the Fire Department Picnic at St. Mary's and commended the firemen who arranged the event.

The Mayor and a few Council members attended the recent Chamber of Commerce Directors meeting, and via zoom met with the State Mental Leadership Program and the Jari Growth Fund. He referred members to the Cambria Somerset Association of Realtors information on the agenda for further review.

He noted the recent Sandyvale Wine Fest was a huge success.

# **CITY SOLICITOR**

Elizabeth Benjamin, Esquire, City Solicitor, had no report but would offer additional explanation of the different resolutions at the appropriate time in the agenda.

## CITY ENGINEER

Vince Seyko, Gibson-Thomas Engineering, presented before Council for discussion of the current paving program and change order No. 1, which was the substitution of the reclamation process to milling and heavy-duty paving on the alleyways. He noted it had been acknowledged and accepted by the City and is currently with the contractor for review and signature.

Mr. Seyko noted the original contract price of \$743,425 was amended to \$714,075, a reduction of approximately \$29,350.

Mr. Seyko reported that 80 percent of the MS4 compliance storm water infrastructure mapping had been completed.

He had discussion with regard to NPDES Permit PAC 1100-70, and an inspection at the site on September 3, 2021 after which a letter was submitted to the contractor to have the work completed at the site. Another inspection was completed on September 17, 2021, and a letter was sent out via Certified Mail to the contractor indicating that the project needs to be finished as intended.

## NEIGHBORHOOD LIAISONS

Reverend King reported that the Welcome to Prospect sign had been installed at the top of William Penn Avenue in Prospect and commended Mr. Campagna and staff for making the brick face around the sign. She noted shrubbery from Vince Lovenduski and the SEADs Garden Center had been placed and a solar light would enhance the area in the future.

She noted the dedication ceremony renaming the Prospect Viaduct Bridge to the Reverend Andrew W. Tilly, Jr. Bridge would be held this Friday, October 15, 2021 starting at 12:00 noon.

Reverend King commented on the mural in the parking lot done by the students of the Greater Johnstown School District. The unveiling would be held in the near future.

She thanked the Johnstown Police Department for installing the speed monitor on Somerset Street to curb speeders. There was discussion regarding a building at Somerset and Franklin Streets, which was recently boarded up by the Fire Department.

Reverend King commented that the Firefighters Memorial Bridge "looks absolutely fantastic".

She requested a moment of silence for the first responders and families of those who recently lost loved ones due to the recent tragedies in the City.

Mrs. Mock noted the West End Improvement Group's Trash to Treasures event was a success. She noted a basket party would be held Sunday, November 14, 2021 at St. Therese Church Hall.

Tony Kassander from Empire Lawn Care volunteered to remove the flowers and clean up the community garden.

Mr. Vitovich reported that Public Works installed the Waterworks in Cambria City, installed inlets on Derby Street, cleaned inlets on William Penn and Franklin Street corridors, replaced traffic mirrors on Franklin Street and at the bottom of Frankstown Road.

Mr. Vitovich commended the artist who painted the caboose at the bottom of the Prospect Bridge.

- It was noted the Iron to Art Festival hosted by the Artists Blacksmith Association of North America (ABANA) is currently being held at PNG Park.
- Mr. Arnone, Council's representative on the JHA, provided an update of statistical information relating to the population of the public housing communities located within the City of Johnstown.

He reported that as of September 30, 2021, the total population of the public housing communities was 2,663. Section Eight voucher holders total 876. This amounts to a total of 3,539. Currently 47 percent of the people living in poverty within the City of Johnstown are being assisted.

- Mr. Arnone noted that the JHA will participate in Trick or Treat events later this month around the City. He noted that in the future JHA plans to modernize properties and has already taken a step to promote community involvement by connecting residents to social service agencies that provides assistance leading to self sufficiency. Mr. Arnone indicated that aging housing units would be replaced, including the Oakhurst Projects, and some existing units would be converted to another form of affordable housing. There was further discussion regarding the matter.
- Mr. Arnone noted several meetings were held concerning the operation of the Saltlick Treatment Plant regarding ways to improve water quality and disinfection byproducts. He noted the plant was given a satisfactory by the state and the operation of the plant was rated commendable which is the highest rating given

by the State of Pennsylvania. Future projects include fine tuning the aeration system and installation of a UV-254 analyzing filtration study to the contact tanks.

Raw water studies of the GJWA compared to other surrounding water sources and bottled water was recently completed. The GJWA drinking water exceeded the quality of well water in many cases. He compared the value of the GJWA water compared to bottled water. The 2020-2021 operation budget would be presented to the Board for review in November and made public upon review.

Mr. Britt commended the first responders, police and firefighters for their actions regarding the recent fires and tragedies in the City.

He commended Mr. Campagna and his crew on improvements done at Sargent's Stadium.

Mr. Capriotti reported that he also attended the Firefighters Memorial Bridge dedication which meant a lot to him as a former firefighter.

Mr. Capriotti also attended the meeting with Representatives Rigby and Burns and staff with regard to bringing the micro mill back to Johnstown.

He commended the firefighters and extended appreciation to all of them, especially the men from the same platoon who responded to the recent fatal fires. Mr. Capriotti suggested that Council get involved with the installation of smoke detectors in City homes using federal funds. There was further discussion regarding the matter including a program that the Red Cross has for installation of smoke detectors.

# **DEPARTMENT REPORTS**

## 1. Public Works

Jared Campagna, Public Works Director, reported that 900 Place, Thorn Place and Frederick Street have been milled and 900 Place had been paved. The plan would move forward to Leslie Place, 8th Ward and on to Von Lunen and Osborne. Barnett and Hopp Streets would be delayed due to the Franklin Street detour but should be started the second week of November.

Tony Penna, Recreation Director, reported the turf had been installed at Sargent's Stadium and pellets are being installed and a final walkthrough would be done at the end of the week in time for the Bishop McCort game on October 29.

Mr. Penna indicated he had been keeping the Mill Rats and Bishop McCort posted on status of the stadium.

Mr. Penna discussed plans for a Game of the Week, which would be held next year on Thursday nights.

He was informed that double sided plywood could be installed over the turf to hold concerts and would be having further discussion with regard to the type of concerts that could be held at the stadium.

Mr. Penna explained that the Roxbury Park hockey rink had been upgraded. He suggested a plaque to recognize the Generals who have volunteered to clean up and paint the rink.

The pickle ball courts have been updated with the use of public donations.

Mr. Penna commented that the baseball fields at the park would be upgraded in the future. The installation of a turf field at Roxbury was suggested.

It was noted that signage would be placed on the playground at Roxbury Park indicating that it would be remodeled in the near future.

Advertising on the exterior and inside walls of Sargent's Stadium was discussed. It was noted the Johnstown Tomahawks would assist in selling the dasher boards which probably wouldn't be installed until the spring.

Plans are underway for a consortium between the YMCA, the War Memorial and the City of Johnstown possibly funded by the 1889 Foundation for safe haven programs at the three locations. Mr. Penna commented that Fichtner Field behind the old Garfield Junior High School could be an opportunity for use and offered further explanation.

# 2. Johnstown Police Chief

Richard Pritchard, Police Chief, reported that recruits would finish up the first week of November and would be assigned to platoons. He and Captain Miller would visit Indiana University of Pennsylvania and the Westmoreland County Police Training Academy to start another recruiting drive.

He indicated the Cuddles for Kids toy drive project would commence in the near future.

Mayor Janakovic was pleased to note that the Chief has made a visible presence in the community.

# 3. Johnstown Fire Chief

Robert Statler, Fire Chief, noted previous discussion with regard to the recent tragic fires in the area. He noted that the Civil Service Test would be held this

Saturday which would provide the list for the next two years. Chief Statler commented that the part-time firefighters are working out, and they "fit into the mix."

# 4. Community Development

John Dubnansky, Community Development Director, reported that two versions of the comprehensive plan is near completion and would soon be presented to the City Planning Commission followed by a 30-day public review. It would then be presented to Council for review at the December meeting.

He noted that there would be discussion with code enforcement officers this week. Two RFPs had been released for demolition of 14 residential structures and 3 commercial structures including the Apryle Jewelers property, the property located at 600 Maple and a six-unit property on Boyer Street.

A demolition grant was awarded a few months ago with regard to the King Building and demolition should begin within the next month.

Mr. Dubnansky noted that 40 resumes were received for the code enforcement officer position. He talked about the various demolition projects.

Mrs. Mock had questions with regard to demolition of a home located at 218 Garfield Street in the West End. There was further discussion regarding demolition projects scheduled to be completed. Reverend King talked about six houses on Fronheiser Street that need to be condemned. Mr. Penatzer, Mr. Dubnansky and Chief Statler will visit the property and decide whether to condemn it.

There was discussion regarding money allocated for Sargent's Stadium and whether that would be placed in the budget as a refund from the stadium fund. Mr. Penatzer commented that would be placed in the 2022 capital fund.

A land bank agreement is under review with JRA for approval.

#### PUBLIC COMMENT - NON AGENDA ITEMS

Linda Russell, 132 Wertz Road, Johnstown, commented about a problem she had discussed with Council last month, which has not been addressed. She noted that she has paid \$18,000 in property taxes over the last 14 years and there had been no police presence, no street cleaning and was forced to install a \$5,000 sewer into her home.

- Mr. Penatzer stated she should be receiving the same city services as everyone else in other areas of the City.
- Ms. Russell noted that Atlantic Broadband employees speed up and down that road when visiting a cable tower near her property. She and her neighbors are requesting signage in that area.
- Mr. Penatzer noted the matter is an enforcement issue and suggested that she contact the police department regarding the matter.
