# JOHNSTOWN CITY COUNCIL REGULAR MEETING MINUTES WEDNESDAY, AUGUST 11, 2021

City Council met in a stated session for the general transaction of business. Mayor Janakovic called the meeting to order at 5:59 p.m.

Reverend King offered the invocation. The Pledge of Allegiance was recited.

The following members of Council were present for roll call:

## APPROVAL OF MINUTES

#### PUBLIC COMMENT-AGENDA ITEMS ONLY

Charlene Stanton, 184 Sell Street, addressed Council regarding Bill No. 11 and Resolution Number One. Mrs. Stanton urged Council to vote no to Bill No. 11, the amendment of the vacant structure ordinance. She noted the current amendment requires a \$300 registration fee and, if passed, Bill No. 11 would require property owners to maintain vacant lots that they are already maintaining.

Mrs. Stanton suggested that Council vote no to Resolution Number One. She noted the City should not be donating money to Vision 2025 for community improvements but should be using that to fix existing problems, hiring more

seasonable help for Public Works, for rat extermination in the West End or to fix the collapsed flood channel walls.

It was clarified that the intent of Bill No. 11 is regarding vacant, property code violated properties that have not been maintained. It was suggested that Mrs. Stanton remain at the meeting as there would be further discussion regarding that matter.

John DeBartola, 1197 Bedford Street, addressed Council regarding the agenda. He complimented Mr. Penatzer for explaining what is being voted on and offering recommendations.

With regard to Resolution Number One, Mr. DeBartola expressed disappointment that the City would be giving money to a nonprofit and referred to it as a "scam".

Mr. DeBartola commented that by passing Resolution Number Three, the HUD/CDBG Funding 2021, the City would be bringing more poverty to Johnstown.

With regard to the appointment to the Johnstown Housing Authority, Mr. DeBartola was concerned that the same people were being appointed. He asked when Council would start appointing new people who will "make a difference" and "not just vote yes and do as they're told".

#### MAYOR:

Mayor Frank Janakovic thanked the AAABA Committee and the Oldtimers'
Association for their annual AAABA Parade, Tournament, housing the teams noting it to be one of the most successful tournaments held in a long time.
He offered special thanks to George Arcurio, the President of the Oldtimers'
Association and all of its members.

Mr. Janakovic noted his attendance at the check presentation in the amount of \$5,000 to the Johnstown Police Department Canine Division at one of the AAABA games in memory of Officer Krupa who had recently moved to Texas

and was killed tragically. A special thank you would be sent to the family for that contribution.

Mayor Janakovic noted his attendance at the recent National Night Out festivities.

Mr. Janakovic noted that he, Reverend King and Mr. Britt attended the 10,000th COVID-19 free vaccine event distributed by Highlands Health Clinic. He offered a special thank you to Rosalie Danchanko for taking the vaccine out to the community.

Representatives from First Energy and JARI hosted a meeting of local business leaders to launch a legacy City program to assist with planning.

## **CITY SOLICITOR**

Elizabeth Benjamin, Esquire, City Solicitor, explained that ordinance offered by the City for purposes of proposing an amendment to the Home Rule Charter was timely submitted to the County Election Board for placement as a referendum on the November ballot.

Ms. Benjamin stated, as referenced during the Public Comment period, Act 55 of 2021 was passed in order to implement certain amendments as made in the Sunshine Act which will go into effect on August 29th of 2021 and requires change to the process for public meetings. She stated agendas would now need to be posted to publicly available websites and other specified locations 24 hours in advance of the meeting. General prohibition making changes to the agenda after they've been posted within that 24-hour period subject to certain exceptions that are included within the law relating to emergencies or other issues that are not feasible. And further providing for a process to be followed, that you do have to utilize one of those exceptions, post an amended agenda one business day following the meeting.

She noted these changes were not expected to have too great of an impact on Johnstown City Council as it pretty strictly adheres to the agenda once distributed and posted to the public but it will become effective August 29, 2021 and the City would then be prepared to monitor those exceptions if and when a potential change arises.

#### CITY ENGINEER

Bruce Graham, Gibson-Thomas Engineering, presented for further discussion two sets of before and after photographs to Council of the Clean Fill Site. He

reported the contractor, Erickson Equipment, would be formally requesting additional funds in the amount of \$50,000 for additional materials and labor for problems on the project which had not been seen previously. Mr. Penatzer commented that after discussing the matter with Mr. Graham and Mr. Campagna, that none of them think it would be in the best interest of the City to continue to operate the site after this project. Mr. Arnone commented that the dump site is being prepared to be a usable dump site in the future and would meet all DEP and Cambria County Conservancy requirements.

Mr. Graham commented that the GJWA has gone over what is involved in the sewer project in the Central Business District and noted a couple locations where the existing sewer line does what is called a "belly" or a "dip", where the line comes across and then drops down and comes back up and fills up with solids which blocks the line and needs to be jetted or cleaned. Mr. Graham noted the only way the matter can be resolved is by Option Three as presented to the GJWA which discusses turning that into a storm water line, and per the contract, once the sanitary sewer is removed from the line, it would be considered a storm line which reverts back to the City. He referred members to drawings of the line for further discussion of that location located right in the middle of Johns Street and Main Street. Mr. Arnone commented on the matter. Mr. Graham estimated the cost of the project to be approximately \$400,000.

Mr. Graham noted that locations on that area of the street would need to use grinder pumps which would be the responsibility of the GJWA but that after the manufacturer warranty expires, ownership would be transferred to the homeowner or business. He indicated that other options are being consider and would provide further information at future meetings.

#### **NEIGHBORHOOD LIAISONS**

- Mr. Capriotti stated he was contacted by a resident of the Eighth Ward who was having issues with low hanging tree branches and went ahead on his own accord and cut the branches down and wanted to thank the person from Public Works who hauled them away.
- Mr. Britt commended Ms. Danchanko for bringing the COVID-19 vaccine out to the community.
  - He also recognized Mr. Arcurio, President of the Oldtimers' Association, for bringing baseball back to Johnstown.
- Mr. Arnone provided an update of statistical information relating to the population of the public housing community located within the City of Johnstown.

He reported that as of July 31, 2021, the total population of the public housing communities was 2,642. Section Eight voucher holders total 874. This amounts to a total of 3,516. Currently 47 percent of the people are living in poverty within the City of Johnstown.

Mr. Arnone reported the Greater Johnstown School District has ended a successful "Summer in the City" program. And the Housing Authority is moving forward to hopefully having back to school programs at those sites during the upcoming year.

JHA is proud to see the Oakhurst Residents' Council within the Oakhurst Homes.

Mr. Arnone indicated that Mike is in bad health and would not be retaining his position on the JHA. He noted that it is the Board's and JHA's recommendation that a former employee and now resident, Darlette Haselrig, be considered for the appointment to the Board.

With regard to the GJWA, the 2020 Audit has been completed and will require approval. Routine sanitary survey inspections have been completed at the Riverside Plant. The sanitary survey inspection takes place once every three years and a full inspection will be given to the GJWA within the next few months. Intensive chemical cleaning of water filters will take place.

New meter regarding software equipment will be put into operation and will be more efficient. The RDM sewer operations building on Napoleon Street has been completed and should be in use by the end of the year.

There were four SSOs in July. Mr. Arnone noted that most of the infiltration into the system is from prior sewer laterals and laterals being converted and a large portion of the problem will be addressed as upcoming miscellaneous projects.

All reservoirs are full and near capacity. Work on the North Fork Dam Project has been approved and should start soon. Valve replacement at the bottom of the dam continues and should be completed by fall.

Mayor Janakovic commented that it is refreshing to see the new JHA director out and about in the City.

Mr. Arnone commented that once the license reader is tied into the system, traffic can be monitored in and out. He stated, with regard to the sidewalk situation, half of the stone had been removed out and sidewalks will continue to be poured.

Mr. Campagna noted a new mirror has been ordered for the upper end of Main Street. There were comments regarding the portable speed sign on D Street in the West End.

Mr. Vitovich commended the Public Works two-man crew who prepared and cleaned up Roxbury Park and Sargent's Stadium for the AAABA Tournament.

Mrs. Mock reported the community gardens and flower boxes continue to do well.

A Trash to Treasure sale will be held September 25, 2021 in the West End.

She reported that the Roxbury Civic Group will host the Cambria County Drug Coalition at its August meeting.

Restenciling the light posts at Roxbury Park will be completed. Additional cameras will be ordered for the lower end of the park.

Reverend King commended the Highlands Health Clinic on its 10,000th COVID vaccine. An award was given to the person receiving that shot. Reverend King commented that any homebound person who has not received the shot should contact the clinic.

Reverend King commended Jared and the Public Works crew for work done on Honan Avenue.

Reverend King commented that she and Mrs. Mock attended the recent Roxbury meeting. She stated this group is "one of the best" community groups and applauded their work.

A Kernville meeting will be held August 20, 2021 at 6:30 p.m. Reverend King noted the SEADS Garden Center, formerly the Flower Barn, has taken over ownership of the garden on Franklin Street.

She noted there would be a renaming of the Prospect Bridge in the near future.

Mayor Janakovic reported that it was brought to his attention that the bike trails coming down from the Inclined Plane are being utilized heavily and there is concern that the trails will start to become overgrown. He ask for volunteers to assist in helping to keep the trails open. Reverend King noted the Capture team from Vision will be conducting a highway cleanup in that area on September 18, 2021.

John DeBartola, 1197 Bedford Street, applauded Councilman Capriotti for inquiring how the \$20,000 contribution to Vision Together 2025 would be spent. He stated Council needed to know how the money would be spent before voting to approve.

Mr. DeBartola referred to a letter from Mr. Jack Williams sent to Council August 9, 2021 regarding whether the mayor has the power to appoint police officers. He asked Ms. Benjamin to comment on the matter.

Ms. Benjamin explained that the matter will be reviewed to make sure Council is appropriately apprised of the proper practice to be followed.

Mayor Janakovic commended Chief Pritchard and the police department for their efforts in acquiring the six new police officers appointed to the force.

Mayor Janakovic noted for the record that a mayor does not appoint police officers.
