RESOLUTION NO. 10739

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JOHNSTOWN, PENNSYLVANIA, AUTHORIZING THE CITY MANAGER AND/OR HIS DESIGNEE TO MAKE ANY/ALL LINE-ITEM ADJUSTMENTS NECESSARY FOR THE MONTH OF DECEMBER 2025 TO BRING SAID LINE ITEMS INTO A POSITIVE BALANCE, SUBJECT TO A LIMIT OF THE AMOUNT OF TOTAL EXPENDITURES BUDGETED FOR THE 2025 CALENDAR YEAR.

NOW, THEREFORE, BE IT RESOLVED AND ADOPTED by the City Council of the City of Johnstown, Pennsylvania and it is hereby RESOLVED AND ADOPTED as follows:

1. THE CITY MANAGER AND/OR HIS DESIGNEE IS AUTHORIZED TO MAKE ANY/ALL LINE-ITEM ADJUSTMENTS NECESSARY FOR THE MONTH OF DECEMBER 2025 TO BRING SAID LINE ITEMS INTO A POSITIVE BALANCE RELATIVE TO THE TOTAL EXPENDITURES BUDGETED FOR THE 2025 CALENDAR YEAR.
2. THE INTERIM CITY MANAGER AND/OR HIS DESIGNEE IS LIMITED TO MAKING ADJUSTMENTS THAT ARE AND REMAIN WITHIN THE TOTAL AMOUNT OF EXPENDITURES BUDGETED FOR THE 2025 YEAR, AND MAY NOT MAKE ANY ADJUSTMENTS THAT WOULD EXCEED BEYOND THE TOTAL AMOUNT OF EXPENDITURES BUDGETED FOR THE 2025 YEAR.
3. THE INTERIM CITY MANAGER SHALL PROVIDE A REPORT TO THE CITY COUNCIL OF THE ADJUSTMENTS THAT WERE MADE IN DECEMBER 2025 PURSUANT TO THIS RESOLUTION. THIS REPORT WILL BE PROVIDED AT THE JANUARY 2026 COUNCIL MEETING AND WILL INCLUDE LINE-ITEM ADJUSTMENTS WITHIN A DEPARTMENT AS WELL AS ADJUSTMENTS FROM ONE DEPARTMENT TO ANOTHER AS ARE TYPICALLY ADDRESSED AND HEREBY AUTHORIZED BY RESOLUTION.
