A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JOHNSTOWN, CAMBRIA COUNTY, PENNSYLVANIA AUTHORIZING THE CITY MANAGER AND FINANCE DIRECTOR TO INITIATE A FUND BALANCE TRANSFER TO ELIMINATE DEFICIT BALANCES WITHIN THE FIRE DEPARTMENT 2025 OPERATING BUDGET:

WHEREAS, the annual operating budget for The City of Johnstown for the fiscal year 2025 was duly adopted by Resolution No. 10679 on December 11, 2024; and

WHEREAS, the City Council has determined a need to adjust the adopted budget to account for unanticipated expenditures within the Fire Department; and

WHEREAS, the City Council desires to transfer existing funds from the General Fund Balance to fund this purpose; and
NOW, THEREFORE, BE IT RESOLVED by the City Council of The City of Johnstown, Cambria County, Pennsylvania, that the 2025 budget is hereby amended as follows:

- **Section 1:** The sum of \$368,000 is hereby transferred from the General Fund Account No.01.000.06.000.00.
- **Section 2:** The sum of \$368,000 is hereby appropriated to the Fire Department Account No.01.412.00.000.00 for the purpose of Salaries/Wages and Benefits.

BE IT FURTHER RESOLVED, that the proper officers of the City of Johnstown are authorized and directed to take all necessary steps to effectuate this budget amendment and fund transfer, and to update the accounting records accordingly.




