A RESOLUTION OF CITY COUNCIL, OF THE CITY OF JOHNSTOWN, PENNSYLVANIA AUTHORIZING THE CITY MANAGER AND CITY SOLICITOR TO EXECUTE THE ATTACHED SETTLEMENT AGREEMENT WITH RASHEED DEEB, TO RESOLVE A TAX ASSESSMENT APPEAL REGARDING PROPERTY LOCATED AT 142 WALNUT STREET, JOHNSTOWN, PA 15901, AND TO TAKE ANY/ALL ACTIONS NECESSARY TO EFFECTUATE SAME.

WHEREAS, Rasheed Deeb filed a Tax Assessment Appeal in the Court of Common Pleas of Cambria County at Docket No. 2024-3943, challenging the combined assessed value of \$594,000.00 assigned to its property located at 142 Walnut Street, Johnstown, PA 15901: and

WHEREAS, after the parties received Rasheed Deeb's appraisal, the parties, to include the City, the Cambria County Tax Assessment Office and the Greater Johnstown School District have engaged in settlement discussions with Rasheed Deeb, and identified a value on the property of \$100,000.00 as a reasonable value upon which to resolve the matter; and

WHEREAS, the proposed settlement agreement is attached hereto as Attachment A;

NOW, THEREFORE, BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF JOHNSTOWN, PENNSYLVANIA TO AUTHORIZE THE CITY MANAGER AND CITY SOLICITOR TO EXECUTE AND TAKE ANY/ALL ACTIONS NECESSARY TO EFFECTUATE THE ATTACHED SETTLEMENT AGREEMENT TO RESOLVE THE TAX ASSESSMENT APPEAL ADDRESSING THE LITIGATION FILED BY FOR RASHEED DEEB, IN RELATION TO PROPERTY LOCATED AT 142 WALNUT STREET JOHNSTOWN, PA 15901 FOR A FAIR MARKET VALUE OF \$100,000.00.




